What? You couldn't make it to Assembly? No problem! It was posted on the area website (three levels deep with no links to the page above it, http://www.area92aa.org/areainfo/index.php).

What? You didn't know it was on the area website? But it was announced at Assembly!

What? You don't have Internet access? No problem! Everyone gets the area newsletter, so you should have found out about application process and deadline there.

What? It was never submitted for publication in either the November or December issues? Well, that would have been kind of pointless since the dead-line was so close anyway.

Concerned about AA conducting its business in such a hurry? In ways that appear exclusionary rather than inclusive? That let the "good" of being prompt get in the way of the "best" of letting group conscience select trusted servants?

Your concern is shared by many, including members serving in the current rotation.

"BASICS OF OUR HOME GROUP—RECOVERY, UNITY AND SERVICE"

I know these words are easily recognized by all of us and that we understand deep down in our hearts how to practice these principals every day in all our affairs. But, how do we practice them? I often find myself stumbling along in the daily grind and forgetting just what they really mean to me and how to blend them into my daily activities, along with the needs of my family.

Let me digress for a moment and talk about the 55th General Service Conference theme this year. You guessed it! "BASICS OF OUR HOME GROUP—RECOVERY, UNITY AND SERVICE." The Delegate chairman, in his opening statement, talked about how we need not forget the group conscience, and to listen like you have no opinion. "This is a whole lot harder than it sounds," he said. I think that, because we all have an opinion or interpretation of how things should work, we forget about the service portion of this statement. Has your group really expressed its conscience to your General Service Representative about the issues being debated, while participating in Alcoholics Anonymous as a whole? And does your home group have a representative who can speak for the group conscience? I know that when I first came to A.A. I just wanted to stop drinking for a while until my life, my job and my family got back in order. I was tired of those late drives home, all alone and lost in some forlorn place. I remember

a time walking on the beach alone meditating (maybe contemplating) my next move, only to find myself at the bottom of a twenty foot drop into the Pacific ocean. I somehow found my way back to the top, soaked through and through, bloodied from a head wound, and having lost my glasses with a sixty-mile drive home yet ahead of me. I made it to work the next day and found a message that my wallet had been found along the rocks, and instructions about where I could pick it up. Hell, I didn't even know it was missing. The point I make here is not to downplay the reasons why we came to Alcoholics Anonymous, but to reinforce the reasons why we stay. I had lost all hope until I found this fellowship and finally became a member—a member in my own recovery, and a member in action with the Third Tradition which states:

"The only requirement for A.A. membership is a desire to stop drinking"

I soon learned that in order for me to stay sober there was more footwork necessary. Membership was for me more than just a subscription to the organization's monthly magazine. It meant work for me and working with others. For you see, there was a Twelfth Step in this recovery program along with a Fifth Tradition, which soon began to govern my daily activities. Membership means more to me today than just showing up for meetings. It means involvement. It means involvement in more than just my recovery. It means more than just unity. It means service to others who have a problem similar to mine, and a dedication to a service structure that

gives every member a vote that counts. As a member, we are automatically registered in this great society of ours, and if I do no more than express my opinions at the meeting, after the meeting, or at casual gatherings, then I do a disservice to the singleness of purpose for which we stand

I am reminded here about some of the things Chuck C. used to talk about when describing how this program works. He told the story of two guys in an invisible boat rowing along and finding a lone swimmer adrift in the water, and then offering the fellow a chance to get into the boat so that his life might be saved. The swimmer replied that they must be crazy to think they had a boat because he could not see one, and he therefore refused to climb aboard. The invisible boat is symbolic of Alcoholics Anonymous, and yes, it can be difficult to see it at the beginning. But if you look a little closer and become just a little more active, you will find a foundation of a magnitude sought by many and found by a few such as I. You may find that you have more to give to this program in the long haul.

Now that you have gotten through all this and I have your attention, let me thank you for all the support given during this and preceding years. I have truly found recovery, unity and service available if I take advantage of the next step in front of me and wish each and every one of you success in the coming year.

We had some discussion on what we wanted at January quarterlies. How do we see our purpose, and do we spend the time wisely?

MOTIONS

- 1. Create a credit line, of \$500.00, for the Area Translation Committee Chairperson to purchase and maintain translation equipment, as deemed necessary by the Translation Chairperson, to conduct Area business. Passed on to October Assembly.
- 2. That Area 92 increases its contribution to the General Service Office for the Delegate's expenses for the General Service Conference from \$800.00 to \$1,200.00 in keeping with Tradition Seven and self-support. This will also be looked at each year by the Area 92 Finance Committee to see if we can send a larger contribution. Passed on to October Assembly.

Regional and Special Forums

Regional Forums originated in 1975 at the suggestion of the late Chair Emeritus of the General Service Board of Trustees, Dr. Jack Norris. They are weekend sharing and informational sessions designed to help the General Service Board, A.A. World Services, Inc., the Grapevine Corporate Board, the Grapevine Staff, and the General Service Office Staff stay in touch with trusted servants throughout the A.A. service structure.

At the invitation of a region, four Regional Forums are held each year. Since the U.S./Canada service structure is composed of eight regions, a Regional Forum may be held in alternate years in a particular region on a rotating basis.

The location and agenda for a Regional Forum are decided jointly by the Regional Trustee, Area Delegates and G.S.O. The responsibility for direct contact with the hotel is assumed by a local A.A. Host Contact working with the Regional Forums Coordinator and Regional Trustee. The Regional Forums Coordinator at G.S.O. distributes registration forms and invitations to groups and service workers through the region and, working with the Host Contact and Regional Trustee, coordinates the details of the Forum.

A region may request a Special Forum which has fewer participants from the boards and staff over shorter time periods. Special Forums require the approval of the trustees' Committee on International Conventions/Regional Forums. They may be designed for remote, sparsely populated or urban areas to serve A.A. members who would not normally be able to attend a Regional Forum. The Regional Forums Coordinator works closely with the Regional Trustee and Host Contact tailoring each agenda to local needs.

There is no registration fee for a Regional or Special Forum. The General Service Board covers the expenses of meeting rooms, transportation and hotel rooms for its board and staff personnel. In many places, area committees, districts and groups cover or defray the transportation and lodging expenses of the trusted servants representing them at a forum.

Forums are intended to be sharing sessions, thus no formal actions result. Forums provide unique opportunities to share and exchange valuable experience, ask questions and spark new ideas.


