I talked about the joys and struggles of my own recovery.

When the time was up and I went to sit down I noticed something. People were standing and applauding just as I have for Saturday night speakers so many times through the years. I stood and joined them. We were applauding sobriety. We were celebrating the joy of recovery.

Technically the version on the web site would not be "identical" to the hard copy version, but we would be adhering to the guidelines on web site anonymity.



Delegate Report

2004 with the first Area 92 Pre Conference Assembly in Spokane. It came by way of a motion that lingered a long time in the Area. A Motion that was changed significantly as time went by and was changed I believe because we seem to want to take things in steps (what a concept) and the motion gave us 5 years to take the step. We voted on a simple motion that started a process that was new to us all. Right after the Assembly that October we didn't know what the new Spring Assembly was going to look like so the officers got together on your behalf to put together an Agenda that might encapsulate all the aspects that might be needed to have a first Spring Assembly.

- 1. First it was a Pre conference Assembly, so the first and most important segment is to help the Delegate get ready for the Conference. A slot of time was given for that.
- 2. Next since it was an Assembly and the nature of an assembly is to

vote on motions that have come to the assembly. These motions come as a result of the system we have in place currently where the groups send their request via the DCM or come to the Area Quarterly with their motions to be voted on and passed on to the next voting assembly. So now we have 2 voting assemblies.

3. Next we had to do all of the other things that we are required to do per motion which is have Standing committee panels on Friday night, GSR, DCM roundtables, Standing GSR DCM and committee reports, and we had to get bids for this Assembly.

superintendents of each facility and the area Director of Corrections.

There is an award for a volunteer group and an individual volunteer for Pine Lodge Pre-Release and one for Airway Heights Correction Center. The group and volunteer are chosen by the volunteer coodinator for each facility with input from other staff.

Other groups that have been recognized are religious groups. The individual volunteers recognized last night were a lady who teaches women at Pine Lodge about mothering skills and an individual from a religious group who works with offenders at Airway Heights teaching them crafting skills.

It's my hope that people reading the letter will think about volunteering to carry the message into the prisons. The inmates cannot have a meeting without an outside sponsor, and they really do benefit from the efforts to bring meetings in. I know that I have learned more from them than they have learned from me. These people have not had all the opportunities I've had. Some will never leave the facility but it is so wonderful to see them "come, come to, and then come to believe."

If you have ever wondered why anyone would go into a prison, you have your answer. The gifts we have received as volunteers by knowing the people behind the walls are priceless.

R&R (Resentment and Relapse)

I believe time will heal his resentment toward me and he will start writing soon, and if he doesn't that's his stuff.

I am one hour into the meeting and I am starting to feel better about life on the inside. How are you on the outside?



Results of Voting on Motions

Change Procedures for Processing Motions

That WSEA92 change its procedure for processing motions in the following manner, throughout the remainder of the 5 year period of motion #2003.2. To have all motions processed at our two Assemblies only, eliminating the quarterly system of processing motions. Our two Area Committee meetings(quarterlies) will no longer process motions. A motion will take 6 months to process and will go from Assembly to Assembly, giving the home group plenty of time to discuss and get background for each motion. However, the Assembly may, with a substantial unanimity vote, decide to pass or fail a motion at an assembly if the body found it necessary. OCTOBER FALL ASSEMBLY: motions from April Spring Assembly would be voted on. New motions presented and passed on to the April Spring Assembly.

This motion was carried over from the October 2004 Assembly. It FAILED.

(The following motions are from the April Pre-Conference Assembly.)

Delegate's Expenses for Board Meeting

That WSEA 92 add a line to the Delegate's expenses to include a line for reasonable expenses, not to exceed \$200, "if" the Delegate from WSEA 92 is elected to a Chair position at the Conference and will be required to attend the January Board meeting representing WSEA 92 and AA as a whole.

This motion PASSED.

Methods of Identifying Officer Candidates

That we eliminate the roll call procedure for the election of our conference Delegate and Alternate Delegate and adopt the following qualifications to serve as Area 92 Delegate. Before balloting starts; the chair shall ask all those in the body who meet the suggested qualifications to stand; the chair will then ask that of these members with the time and energy available and willingness to serve to please remain standing; the A.A. members still

standing will be the roster for the election. Each individual's name (suggest full names) and district shall be read aloud and written on the board. The election will begin using the 3rd legacy procedure. Nominations will not be accepted from the floor. The qualifications will be the same for the Alternate Delegate.

Suggested WSEA 92 DELEGATE QUALIFICATIONS*: o Has served as General Service Representative(G.S.R.)

- o Has served as District Committee Member(D.C.M.)
- o Minimum 5 years of continuous sobriety, which includes active participation in local and area affairs. *FOR COMPLETE LIST OF QUALIFICATIONS REFER TO THE A.A.SERVICE MANUAL, PP.S45-S46.

This motion FAILED.

Specification of When Motions Take Effect

That Area 92 add a line in the handbook that reads: "All motions not specifying the time they will take effect, will, if passed, take effect at the end of the assembly."

This motion PASSED.

Create Handbook Committee

That WSE Area 92 add a permanent, rotating, non-funded handbook Committee under the responsibility and appointment of the Area Secretary. This Committee would be made up of

the Area Secretary and 4 A.A. members. The Committee will be responsible for keeping the Area Handbook updated.

This motion PASSED.

Purchase Translation Receivers

That WSEA 92 purchase 10 more translation receivers for the Translation Committee for use in translating for all Area 92 functions. (Floor Motion)

This motion PASSED.

The Insider:

The Phone Call You *Haven't* Heard!

So you went to your first pre conference assembly. What did you think? Did you like it? Yes, it does look like the October assembly except for the General Service Conference part. Why did we vote to have a second assembly? So we could all get together in one room and let our delegate know how we think an agenda item should be handled at the General Service Conference. We used to have pre conference workshops in several different locations and the delegate would travel around and listen to the different groups share on the General Service Conference agenda.

Why didn't that work? Well, actually it did work fairly well; it just wasn't the best we could do. Remember that Bill W. said that sometimes good is the enemy of the best. It took a lot of time and energy away from the delegate when preparation for the conference was the first priority. Even more important, the delegate had to listen to several different group consciences and try to determine if they had all been together, heard all of each other's ideas, would the conscience have been the same. No, the service manual does not talk about area motions. Rather, it talks about the spiritual principles of doing the business of AA at all levels and makes the process very clear. Robert's Rule's of Order? Yes you are right. We use a loose version of that

document. When I was a delegate, that statement about using a loose version of Roberts Rules of Order was in my delegate package. When I got to the conference, I asked the Chairman of the board, the General Manager and the conference coordinator what that meant. Their answer to me was that we have to have a way to put a motion on the floor. So we use the motion process including a second from that document. We also use the "call for the question" process. From there, we pretty much leave Robert behind and use the spiritual principles of AA.

The Spiritual Principles? Well you could start by studying the 12 Traditions. Then, you could study the 12 Concepts. By yourself? Only you can answer that. In my case, I did it with someone who had done it with someone else and had actually utilized it. Why? Well, my magic alcoholic mind likes to interpret. I wanted to know what was really there, not my interpretation.

I'm so glad you called. I think it's great that you left the pre conference assembly with a sense that you had participated in something larger than your home group and that you are beginning to understand about AA as a whole. That is a big step in General Service.

October election assembly? Yes, I'll be there, will you be there? Well, this is where you get the opportunity to elect a delegate from area 92 to go to the General Service Conference. Yes, we elect the rest of the area officers also. Why don't you call again as we get closer to October and we can have a little chat about elections and how we do them in AA.?
