## Pamphlet P-26 Motion



At the October Assembly in Post Falls, Ron L.R., GSR for the Open Eyes Group in Post Falls, brought forward a motion regarding printing of AA pamphlets. The motion called for pamphlet titles to always be on the upper third of the pamphlet cover so that it will show when the pamphlet is stocked in a display rack. "A.A. in Correctional Facilities" (P-26) and "The Twelve Concepts for World Service" (P8) are both titled at the bottom of the pamphlet cover. "LGBTQ Alcoholics in A.A." (P-32) and "It Sure Beats Sitting in a Cell" (P-33) are titled in the middle of the page so that the title would be covered by pamphlets in front of it when it's in an AAWS-issued display rack (M-8).

This is a great opportunity to watch how the helpful idea of one AA can affect AA as a whole. It's not a fait accompli (done deal) yet, but here are communications to show us what's happened so far. Thank you to our Delegate, Allen D., for putting our motion forward and keeping us informed as it moves along.

## How I Found A.A.

Hey, what's up? My name is Josh. I'm in recovery for the 1<sup>st</sup> and longest time ever and I am grateful for it. I am like almost anyone else who found a positive group where I can be me without being judged. Who would have thought I would have found it in a prison AA meeting?

How did I find AA? Well, that's easy. Part of my J&S (judgment and sentencing) is that I take a chemical dependency (C.D.) class. When I arrived at Airway Heights, I knew I needed to take an AA or C.D. class of some sort and since it has been so hard to get into C.D., I took it upon myself to sign up for AA on a Wednesday night. I was quiet for the first 12 sessions I went to, but I quit going. A month later I was enrolled into a C.D. program and was told I had to attend 2 self-help groups a week. A list was provided of classes and dates to attend AA meetings, so I picked Saturday. And the rest is history.

This group was different from the first AA meetings I attended. I had this sense of relief, a positive vibe from all the people in the room. I also knew some of the people which also eased my mind. I started to roam, curious about what to expect. Everything was organized. They had a secretary and a group of people who volunteered to read from cards. You weren't pushed to speak and when someone did talk, it was encouraging. My second meeting was the same and at my third, I stepped out of my box and volunteered to be secretary. Was I nervous? Yeah, because speaking isn't a big thing for me, and I didn't think I had anything to give someone who is in the same box. But I guess I did alright. I was complimented and everything, which was an ego boost. That made me want to sign up more and now I'm scheduled to secretary 2 more times in the coming months.

Each time I go to the Landing Place Group (LPG), my confidence is built up. I am

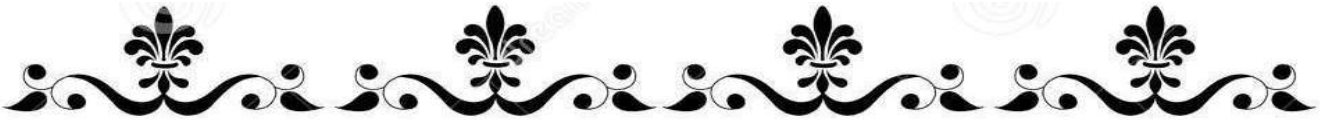


inspired by the individuals who step out of their comfort zone and tell their life story. There is no judging, which is a shock, being that I'm in a place where it seems as though judging is the norm.

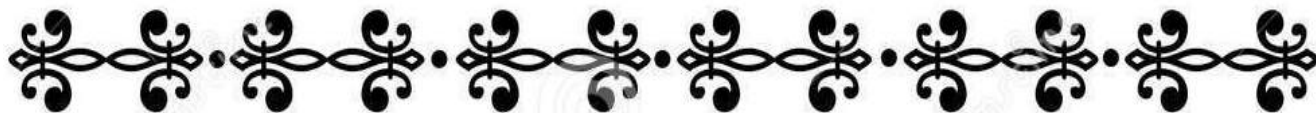

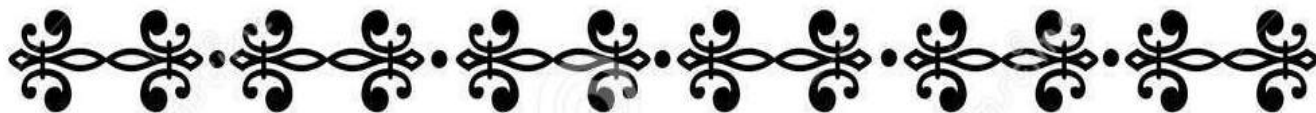
### **District 22 - Dennis D.**

We are pleased to announce that Alcoholics Anonymous World Services, Inc., has licensed the Meeting Guide technology. Meeting Guide was launched in November 2015 and provides a platform for local A.A. entities (Areas, Intergroup/Central Offices, Districts, etc.) to post their local A.A. meetings and currently provides information to more than 100,000 users, reflecting some 86,000 meetings. Since the meeting information is all made available through the app's mobile-friendly interface, those seeking a meeting have a simple, one-stop place to look.

The collated meeting information will be available in the future through G.S.O.'s website, [www.aa.org](http://www.aa.org), and will be a component of the proposed A.A.W.S. app. The intent of incorporating the Meeting Guide component is to make it easier for members to find A.A. meetings.

A.A. Intergroup/Central Offices, Districts and Areas that provide online meeting lists are invited to have their meetings displayed through the Meeting Guide. If you are already synchronizing your meetings through the Meeting Guide app there is no additional action necessary. When the new [aa.org](http://aa.org) website launches at some point in 2019, your information will be seamlessly included.

Please note the meeting information database will operate completely independently from the Fellowship New Vision (FNV) database that is currently supported by G.S.O. Meeting Guide is a separate tool that offers A.A. entities full control of their local meeting information and collects it in one place. Users of this new portal will be linked to the service entity providing the information. Participation is, of course, voluntary, but the more connected the service is to the Fellowship as a whole, the more powerful a tool it will become.

The current listing of Intergroups and Central Offices and other local entities in "A.A. Near You" on [aa.org](http://aa.org) will not be impacted. Those wishing to contact A.A. in their community will still have access to the information that is currently available on the site.

We have developed instructions about how to connect with this new resource at <https://meetingguide.aa.org>. If you have any questions about this initiative or how to synchronize your meetings to this database, dedicated support is in place. We welcome your input and suggestions.

## District 25 in the Spotlight!

**District 25** is a linguistic district that includes Yakima, Wapato, Toppenish and Cowiche (official address says Tieton). Cowiche has the northernmost and westernmost meeting and Toppenish has the southernmost and easternmost. There are seven groups in District 25 that hold a total of 35 meetings/week. Meetings are held in community centers and no two groups meet at the same place. Every meeting is an hour and a half long.

## Proposed Agenda Items for 2019 GSC

“The final agenda for any Conference consists of items suggested by individual A.A. members, groups, delegates, trustees, area assemblies, area committee members, and directors and staff members of A.A.W.S. and the Grapevine. The Conference considers matters of policy for A.A. as a whole, and there are tried-and-true procedures for placing and item on the agenda in the most effective way – or, when the suggestion does *not* concern overall policy, for routing it to the most appropriate part of the service structure.

If a G.S.R. has an idea for an agenda item, chances are he or she will want to discuss it first with the group, then at a district or area meeting, which can then forward it to the staff member at G.S.O. currently serving as Conference coordinator. An A.A. who is not part of the general service structure can give the idea to the group’s G.S.R. or write directly to the Conference coordinator.

Whatever its origin, any agenda item follows the same path to the Conference agenda: The A.A. staff studies it in the light of previous Conference actions, then passes it on to the trustees’ Conference Committee or the appropriate Conference committee. Usually, the trustees’ committee determines the most appropriate way of programming it – as a workshop or presentation subject, a proposal, or a committee concern.”
