Wishing Area 92 a 2020 Holiday Season that is filled with gratitude!

Given the current challenges facing global humanity, I confess to struggling a bit before choosing the above salutation and topic for December's Newsletter. Here is why.

Enlightenment came the evening of Dec. 5th after sitting through a truly remarkable, first-ever, virtual U.S. and Canada (USCAN) East Regions Forum. An announcement and flyer about this Forum, and the upcoming Dec. 19th USCAN West Regions Forum, was distributed across Area 92 and posted on our Website Events page in November.

Not surprisingly, anyone could register and attend - free. Indeed, 2036 members were registered in advance with main session attendance staying well above 1000. While most came from the East Regions, there were many attending from the West Regions including several from Area 92.

The Forum Program Committee worked with the Trustees and Delegates to select panel and workshop topics of keen interest to the attendees and recruited moderators and panelists with substantial relevant experience. These participants were drawn from Provinces of Eastern Canada and from the Central and Eastern States in the U.S. Key members of GSO and Corporate Boards and GSO Staff brought additional knowledge and information. Importantly, substantial time was allocated and well-used for comments and questions by attendees. I found every session thoughtful and intriguing. The closing Past Trustees Panel was profoundly moving.

As some of you may be aware, the normal, in-person 2020 Regional Forums had been cancelled due to the pandemic. Many of us who have previously attended were quite disappointed that our Pacific Region Forum was one of them. Meanwhile, the idea of holding combined, virtual, multi-regional forums, was being suggested by Sandra W. from the GSO staff. The idea was discussed at GSO Board meetings and among the Trustees earlier this summer. Sandra pointed out that doing this would mirror the AA program's admonition that we "go to any length".

Shouldn't the AA Service side of our triangle do the same?

When I learned of Sandra's rationale, it struck me as compelling and reminded me of one of the truths I heard frequently repeated by the men of the New Elmwood Ave. Group where I got sober. They impressed on me that gratitude is <u>not</u> an emotional response caused by external conditions in my life, it is a state of mind that I must reach inside myself and choose. For an alcoholic like me, "*living life on life's terms and not picking up a drink"* is the vital component of making that choice. The new Elmwood Ave. men were insistent that it does not matter what the conditions are around me, it only matters what I do. I attended the Eastern USCAN Regional Forum, and was filled with gratitude.

Hello AREA 92

Where Has the time gone?? It is already December and Christmas is right around the corner. I will not say I am sorry to see the year end. I am hoping for a healthier and less challenging New Year. Zoom meetings have been a saving grace in so many of our AREA events. Regardless, we still have a lot of Zoom challenges to iron out. Let us all hope and pray the New Year will open up more and we will be able to get more than a cyber hug. LOL I am missing all of you so very much.

At the end of December, I will prepare a year-end P&L statement to present at the January Quarterly.

The 2021 Budget will also be prepared and ready for perusal. In the meantime, please do not hesitate to get in touch with me to ask for budgetary answers to pass on to your home group and District. I am working hard with all your interests in mind to stay completely transparent.

We have nominal monthly bills. They are more staggered throughout the year, with the bulk being in the beginning of the year. Zoom meetings have saved the AREA the cost of hotels, meals, registration, and travel for all of the chairs and appointed officers. Needless to say, with this temporary set-back our treasury is growing.

However, because of Covid-19 GSO has had to dip into their reserve account. Part of the issue is most likely lack of contributions because the majority of groups are doing zoom only and possibly not getting 7th tradition monies. Covid 19 has also caused a lot of new, unexpected expenses. What is the Reserve Fund? Answer: The Reserve Fund is G.S.O.'s prudent reserve. Its principal purpose is to provide the financial resources to continue the essential services of G.S.O. and the A.A. Grapevine for up to a year in the event of an unexpected and substantial reduction in the normal revenues of the organization. Question: How are G.S.O.'s services funded? Answer: Approximately 80% of G.S.O. services' funding

comes from group contributions, the Birthday Plan, central office/district/area contributions, and excess funds of A.A. events or conferences. The balance is made up of profits from the sale of A.A. literature.

With our assembly being online we did not incur any additional debt, besides our monthly bills. Our beginning balance as of November 1^{st} was \$27,742.79. We had expenses of \$252.00 (storage) and \$788.16 (Newsletter). Our deposits were \$2,052.69, leaving our checking account balance \$28,755.32. Our Prudent Reserve is \$2,500.30.

I am so honored to be serving as your WSEA 92 Treasurer. As I prepare to begin a new year in that same roll, I pray for your health, happiness, and prosperity. God bless you all. Please send all contributions to:


