Hi Folks,

February was a busy month for me. I attended the 58th International Women's Conference in Santa Fe, NM the 10th - 13th with over 1,400 women in person and over 6,000 virtually. It was an amazing event of recovery, unity, and service.

I worked with several people on the GSO agenda summaries. I am so grateful for the all the help I received. I had some fear at the beginning of the process, but I have learned to ask for help. Thank God this is we program.

We had our archives steering committee meeting on the 17th and discussed researching locations in Spokane and vicinity for a new repository location. We will be putting forward a motion at a later date. The storage unit at Airway Heights is climate controlled but it is not within the parameters needed for preservation of our history.

Area Archivist

Hi Everybody!

We have had a very busy and productive month in Archives again. I have been working hard continuing to catalog and prepare some very old documents for storage. I have recently been working on Mike McMurtrie WSEA 92's Panel 54 Delegate's work. He has a very detailed record from before our split from Area 72 through the change. There is also a beautiful velvet display of all his pins and other items of the 55th General Conference he attended. I am hoping to have it framed so we can display it at Assemblies. I have also created a storage box for all our volunteers name badges and have many volunteer badges archived with their pins and lanyards all intact. I am so grateful I get to do this work.

I need to report also that I have been coming across some very damaged documents. Due to our current repository conditions, I have found documents that are bleeding ink onto each other and sticking together and onto binders. I have found 3 binders like this. This is due to the temperature and humidity levels being outside the parameters of desired archival levels. In order to maintain a desired climate, the temperature level should be at 70 degrees Fahrenheit and the humidity should be at 45%. Our numbers are well outside the desired levels. Old staples that are rusting are also damaging the documents and need to be removed. The rust needs to be removed with a chemical so it will not cause further damage.

When we rented the current storage facility, we were told that it was climate controlled and it is if you are not trying to store precious archival materials in many forms. When we purchased the hydrometer that measures these conditions is when we discovered why our collection was in decline.

This means that we are losing our history in real time. This is why it is urgent that we find a new repository so we can house our collection SAFELY. A new repository would also provide a place where those that want to help can come and learn what I do so we can handle and store our collection safely and move into the future by digitizing our collection. The current repository makes that impossible since electricity isn't readily available.

There is so much work to do but a good start will be finding a new repository that will provide our needs ASAP. We ask that if anyone has a lead on office space in the Spokane area with 600-1000 square feet (not within a flood zone of course), facilities, heat and air conditioning to maintain desired archival conditions please contact anyone on the Archive Steering Committee. The first step is finding a place so we can put in a motion for the funding.

If we all work together, we can make this happen. Thank you in advance for helping to make a new repository a reality.

As we gradually transition to business as usual in Alcoholics Anonymous, I hope we can lock hands and bring the message to those that haven't had meetings in such a long, long time. Hybrid Ad-hock Committee

Report for the Area 92 March Newsletter

The Hybrid Ad-hoc Committee has met three times.

The Committee is made up of two GSRs, 1 Alt-GSR, 2 DCMs and 4 members. Someone volunteered to be the Secretary. We decided to meet the first and third Tuesday of each month for one hour. District 2 provided a virtual meeting room specifically for this purpose.

First, we reviewed our scope given to us by the Area Chair who created the ad-hoc committee.

In our October 2020 Inventory these two Questions were put forth to the Area 92 Body.

1. Is technology and computer software changing the way our Area does business, and how does it affect participation by groups and members?

2. Will the Area, Area Standing Committees, and Districts continue utilizing Virtual Conferencing after the Pandemic?

The Scope and work of this committee will be to discuss practical implementation of an Area Hybrid Meeting Process. The fact-finding process and discovery related to the four primary questions should result in tangible suggestions to the Area 92 Body, that may result in future motions presented for discussion and vote.

The “four primary questions” are:

1. To determine by what process can Hybrid Meetings be practically implemented in Area 92?
2. What will be the financial impact to the Area?
3. What changes to the Area Handbook and Supplements are needed to support this new process?
4. By what means can the Area body stay informed, educated and participate in this process of evaluation, adaption or change and implementation?

Additional questions are:

- a. Who in the Area 92 has the delegated authority to determine whether an Area 92 event should be in-Person, hybrid, or virtual/online?
- b. Should a list of commonly used terms be added to our Handbook and supplements to create a common “dictionary” of technical and related terms to assist members of the area use and relate to a common technical language?
- c. What changes to the technical requirements might apply to our Handbook Sections 2.0, 2.1, 2.2, and 2.3?
- d. Should a new section be added to this section specific to “Hosting an In-person/ Hybrid / Online Standing Committee Workshop?
- e. Should a registration fee be charged to an Online participant for In-person / hybrid events/ online Events? (Assembly and Quarterly, workshops)
- f. What special equipment might be needed for Hybrid Events? (Cameras, Computers, Lighting, Projectors, stands, etc.)

Then we talked about what our sources for reasoning should be: existing Area 92 Handbook and the How-to-Host supplements, our 12 Traditions, the AA Service Manual and a dab of logic. We agreed to consult other Areas and brought a little bit of information back from 05 about their experiences. We shared about our personal experiences in the decision-making process with our home-groups.

At our second meeting, since very few of us reviewed the Area Handbook, Concepts, and How to Host a Quarterly/Assembly the Chair went over her thoughts on these.

1. Who makes the decision?
2. Under what conditions?
3. Who will have responsibility for the equipment?
4. What needs to be changed in the Area HB and How to host a Quarterly/Assembly?
5. What info is available to use as a framework? Concepts, Service Manual, Logic.

Our Concepts and Traditions talk about delegated responsibility “Trusted Servants”

Referring to the Area Handbook-

- 2.3 Chairperson - leadership role, smooth running
- Alt Chair - works with Host Committee, verifies room setup
- 8.10.1 Tech Chair/Tech Committee - participates with assistance and education of use of technology
- Management and maintenance of tech devices, Software Licenses and assist in setup.

Referring to the Service Manual and the Concepts (Rainey will post the New Service Manual to the Share Drive)

1. "Collective Conscience" Apply to Area
4. "Right of Participation" Hosting Committee
5. Minority Opinion must be heard
6. Chair, Alt Chair, Treasurer working with Hosting Committee
7. Not a legal document, but the financial impact of the Area
9. Trusted Servants and their performance
10. Most important - Empowerment of people to do their positions

Conversation was robust at our third meeting. Here are some initial ideas we discussed and generally agreed upon:

1. Hybrid meetings ought to be the new normal because it makes the events Accessible to more people. If we were to make a motion to this effect, and it were to pass, the "who makes the decision" would be answered: the Area. This, we think, is the most advantageous way to go. It serves the most people, extends the opportunities to serve, and is decided by the body, not by any one person or persons.

2a. Supposing that does not happen, who would be responsible for and authorized to make the decision of whether an event is in person, online or hybrid? Why? We referenced the Concepts a lot.

We talked about:

- Leadership in the Service Manual and the Concepts,
- Leadership in the introduction to the Area 92 Handbook
- Ultimate Authority and purse strings of the home group
- Trusting our Trusted Servants
- Host committee is closest to the venue
- Ultimate authority and delegated authority
- Responsibility and authority
- Final authority – who looks around and takes the sense of the room?
- Elected Trusted Servants vs appointed Trusted Servants
- DCMs being part of the Area Committee
- The WHOLE Area committee
- Area Chair as "administrative leader", Delegate as "communications leader"
- Chairperson is the key administrator for the Area, is elected by the Assembly; we chose the person ourselves and have confidence (trust) in their ability to do their job as an administrator
- Delegate might have a broader perspective, a bigger picture
- Treasurer as a Trusted Servant first, financial custodian second
- Making decisions for the good of ALL the Area
- The ultimate authority is the home groups
- DCM's responsibility to the home groups

2b. What process or procedure would be best and why?

- We talked about:
- Polling process as referenced in the Area 92 Handbook
- A sense of the Area
- Chain of communication: home group -> GSR -> DCM -> Area Chair
- How long ought the polling process take? Much discussion here. Some thought 3 months, others thought 2 weeks. We want to determine a process that will "consult" the homegroups. Whether people participate in the polling process is out of our control. This discussion is unfinished.

This applies to A) deciding to do hybrid regularly and therefore not needing to determine who decides and how, and to B) identifying the chain of authority from the home group to wherever and to C) polling to get a sense of the Area.

A.A. Amistics

Amistics is a term used for describing "the choices that different cultures made as to which technologies they would, and would not, make part of their lives."

This terminology given to us by the fiction writer Neil Stephenson, I find most relevant in describing the our A.A. Fellowship of the of the 21st Century. A.A. Comes of Age 2.0, our current General Service Conference theme this year is a possible echo of this sentiment.

In his novel, Seveneves, sci-fi author Neal Stephenson coins this intriguing term: "Amistics". Amistics derived from the Amish principle of the selective use of technology, the example Stephenson's novel has in mind is not – as you might expect – weapons or artificial intelligence. Instead, his imagined future selects an increasingly ubiquity... an example given describes how the Amish use vehicles with wheels like bicycles, horse drawn carriages and roller skates and skateboards. Any type of motor driven vehicle like a car or motorcycle is un-acceptable and un-spiritual, according to the Amish. Thus, we have this new term of modern anthropological value, being used in new studies of community and culture. You will find this term on the internet and Wikipedia.

So, we find ourselves in a new landscape of A.A. Amistics and technology, that is being used by various groups, districts and areas, all leading to a future where each entity should have its right to exercise its use of technology, in the spirit of Tradition 4 as it seems appropriate.

Not so long ago, the action of bringing in a camera or recording device, into any A.A. Meeting would find that action meet with firm opposition. It was not done under any circumstance. We needed to protect our 11th and 12th Tradition. Now we find ourselves conducting and webcasting meetings on the internet, hundreds of times a day across the country by groups, districts and areas that have adopted this use of technology. This is perhaps the most obvious proof of concept regarding A.A. Amistics.

Years ago, we had the telephone and typewriter, but we strongly suggested that our members put "pen-to-paper". Now today we have stylus to tablet, or text to screen. I know of a few sponsors that refuse to allow their sponsees to use a computer to write out their step work.

One group requires that the reading of the steps and traditions be from A.A. printed Literature, Service Conference approved. Other groups are okay with members reading from cell phones and tablets.

It may come in our lifetime that books could go out of use because the cost of paper and printing becomes prohibitively expensive, compared to the cost of a digital download.

When I got sober in 1988, there weren't cellphone, computers or internet. My first sponsor gave me a roll of quarters to use at the pay-phone so that I could call him for a ride. Now cellphones have become common place and even most newcomers have access to this technology, even though the use of which might be still like picking up that 1000-pound phone. At some time in the early 2000s or so the phrase "please silence your cell phones" entered most of our meeting formats overnight.

Paper schedules are still in use quite a bit, but the new "Meeting Guide App." Has arguably become our #1 12 Step tool, right alongside our 4th Edition "Big Book".

A long-standing tradition of passing the basket for our 7th tradition, is now seeing the challenge of electronic fund transfers, like Pay-Pal or Venmo money apps.

We used to use overhead projectors, now we use PowerPoint Presentations.

Electronic Newsletter, Emails, Video-conferencing, Websites all have become the normal models of our A.A. Business Structure communication.

30 years ago, we printed out phone-book like backgrounds for the General Service Conference. Then we were able to burn CDs for the Groups. Today we have all this information for all members available on our website. Interestingly though, not all Areas provide summaries or the Agenda Background for their groups and members. I find this fact most curious, given the technology available.

I hope to live in a future "Fellowship of A.A." where the rights of all members are considered. That the level of whichever technology they consider of value, is respected as an application of their right to apply Tradition 4. That whatever that use or level of technology, we still include those that have the right to be autonomous or different in that choice.

When it comes down to it, it is all about choice, and the right to choose. Once we were driven under the lash of Alcoholism, we had lost that power of choice. Today as Alcoholics who have recovered, the "Power -of -Choice", we find most precious and cherished.

So, as we find ourselves in this new age of technology, we pray for acceptance of those that may choose differently, the courage to apply what we have learned to help others, and the wisdom to use whatever technology we may use in a kind and loving spiritual way.

And truly I kind of like the Idea that an Alcoholic Amish skate-punk thrasher will always have a place in Alcoholics Anonymous, skating the road to happy destiny!
