### Area Secretary - no report

#### **Area Archives Chair**

The Area 92 Archives Steering Committee is submitting this letter to the Area 92 Newsletter with the intention of adding historical context and the Archives Committee vision to the failed motion presented at the April Assembly and to be presented again, to the Area at the October Assembly this fall.

In 1957, Alcoholics Anonymous published the book A.A. Comes of Age, 22 years after the founding of Alcoholics Anonymous. The book captures the creation of the Fellowship and the growing pains of the early days in fine fashion but the message of the book is that the Fellowship had, in fact, grown to the point of being responsible for itself, taking care of the business put before it, whatever that might be, with a loving God and a Group Conscience as our guide.

In 2016, as Area 92 turned 20 years old, many of us in the Area felt that we had, in fact, Come of Age. The Archives Committee saw this as an opportunity to grow in our responsibility to the Area and so in 2019, the Archives Steering Committee and the Archives Chair started to research how other Area Archive Committees did their work and presented a motion to the Area to create a new "Archivist "position and keep our "Archives Chair" position. The purpose of this action was to have an "Archivist" to exclusively do the archival work and still have an Archives Chair to report to the Area. This motion passed and for the first time in our area's history we had an Archivist, a collection scope, a commitment to digitizing our material etc. everything but a "repository to do the work, hence the current motion to the Area.

Unfortunately, there seems to be some misunderstanding about the motion presented in April. It was not meant to convey a crisis situation but to present an opportunity. The Archives Steering Committee is tasked with the responsibility of finding a "repository" for the Archives and as such has been researching and discussing numerous possibilities for the Archives and has come to the conclusion that a "repository" of the dimensions and costs presented in the failed motion is needed to take the next step in the growth of our preservation of our history as an Area. If the next attempt to obtain a "repository" fails in October, the Archives will remain in the storage units as they are now.

This brings us to what would a "repository" look like. The Archives Committee's vision of this would be a 600-800 sq ft. facility with heat and a working / storage area for the archivist with power for printers, computers etc., a display area for our books and memorabilia for viewing from the fellowship and bathroom facilities. Our vision also includes the digitalization of all paper documents and ultimately a searchable database for all of our documents. This data base would be available to any member wishing to visit the repository and would serve as a tool for future generations of Area 92 to research these generations successes and failures of Area 92's Fellowship.

In closing, the Archives Committee hopes this attempt at explaining some of the thinking and the good work will be beneficial to the Area and add context to the discussion we will be having going forward.

The \$1,500.00 per month might seem a bit much to some but one must remember that the Committee cannot make any commitment without sufficient funds and would ill serve the Area with constant motions requesting more funding. It does not mean we will be spending \$1500, unless that is what it takes for obtaining a repository that fits the above needs for space and utilities.

#### Archives Steering Committee

DCMs, Alt. DCMs, GSRs, District archivists, and all interested in learning about archives are invited to join the archives session at the standing committee workshop on Saturday June 18th at Manito United Methodist Church in Spokane. Some of the things we will cover are archiving basics, purpose of archives, and reviewing the district archives handbook (copies will be available). There will be a Q&A period. This is your opportunity to gain experience about cataloging and everything you wanted to know about archives and were afraid to ask. We may not have all the answers, but we can try to find them. We will also have a sign-up sheet for those who want to attend a training session. I hope to see many of you there.

Another busy month in Archives! We had a small work party on May 14, 2022 with Sara, Steve and Gabrielle. We inventoried, boxed and stored about half of our precious book collection into special containers but more supplies will be needed to finish the job. We had to drag tables out of the small storage units and into the hall to get enough light to

see what we were doing. We kept our coats on because it was still very cold there that day. I usually transport what I'm working on to my home where there is electricity, heat, and good lighting but I did not want to do that with the books because of the weight and risk to our valuable collection. I am looking forward to the day when we have a repository where we can have bigger work parties (only a few people can work in the storage units at a time), electricity and everything we need right there.

I had the absolute honor and privilege to work on Jan and Fran Polek's donations of their service work over the past 50 years in both Washington Area 72 and Washington State East Area 92. They were one of the few couples in the country who both served as Area Delegates (Fran WA Panel 27 and Jan WA Panel 33). They were both very involved in creating the new delegate area and the transition. Jan also went on to be an A.A. World Service Director and Trustee. I spent many many hours reading, identifying and cataloging the amazing work they accomplished during their time in A.A. I am going to be sharing some of their story and what I learned about the Area 92 transition during the round table discussion at the Standing Committee Workshop on June 18th. This is what being an archivist and archiving is all about. To be the Keeper of Facts and capture and preserve this amazing history.

I was so very sorry to hear of the passing of our first WSEA 92 Delegate Ben Biegler who served on Panel 46 in 1996-97. He was also very instrumental in the creation and transition of our new delegate area and put many years of his life into A.A. service. His legacy and contributions will live on in our archives.

Please join us for the Standing Committee Workshop roundtable. We are going to share as much information as we can about archive basics, why we archive and GSO guidelines. There will be a session on how to catalog and a question-and-answer session as well. Don't forget to register and bring a dish for the potluck lunch!

Treatment/Accessibilities Report EOM May 31, 2022

Dear Area 92 Family,

May has been a remarkably busy month for Treatment/Accessibilities in Area 92. We had a standing committee meeting on the  $2^{\text{md}}$  of May. District 12 passed along information to me about two treatment centers in their district. I will be sending them Grapevine Subscriptions from our Area. I have also submitted paperwork for two treatment centers in District 14 to receive subscriptions, Thank you Lisa. I also submitted a Public Records Request to the State of Washington to receive a list of Alcohol Treatment Centers located East of the Cascades. This will enable me to contact the Treatment Centers and offer our help with carrying the message to their patients, establishing "Bridging the Gap" contact information for them and identify Treatment Centers about which we may not even know. I have received a response that they will be gathering the information for us, but it will not be ready until August.

I attended a service workshop in Yakima, sponsored by Districts 6 and 20. Thank you for making me feel welcome.


