

We had a lot of fun at the Standing Committee Workshop in Spokane. Valerie, Gabrielle and I shared a lot of information about Archives and I brought a small Archives Display including a 2nd Edition First Printing of the Big Book signed by Bill W. himself. I was able to share some Archive basics and guidelines and some amazing history on Jan and Fran P. plus Area 92 history. It gave me an idea to go deeper into the step by step timeline on how we became a New Delegate Area so I am putting that together as I catalog Ben Biegler's donations, who is our very first WSEA92 Panel 46 Delegate. This is going to take some time but I believe it is a project well worth putting the time into.

A question came up during the workshop that some members are wanting to know the number of items we have at our repository. I answered 50,000 items off the top of my head as my best guess but at our recent Archive Standing Committee Meeting, I was told my guess was way off. The number of items we have that include documents, reports, shirts, hats, cups, plates, pictures, tapes, cds, books, pamphlets, fliers, pins, coins, buttons, records, banners, maps and many other things numbers more in the range of 100,000. So much for my math. I wanted to give the Area an accurate estimate.

I am really hoping the motion passes for the new repository so we have an appropriate place to receive, process, catalog and safely store our precious priceless Area 92 history. I did come across more damaged (bleeding) documents as I was processing Jan and Fran P's items from the 60's and 70's which are concerning.

I believe this new repository (if Area 92 decides to go forward) will be a place that we can come together to view, learn and enjoy our history. It will belong to all of us.

3 Forks Motion for 2023 General Service Conference

Motion: That the General Service Conference take an advisory action as it relates to the present language in 'Pass It On'. Specifically replace the references to alcoholic African-Americans as "colored" and "Negroes" on pages 316 and 317 with language that is respectful and inclusive.

2021 GSC titled "AA in a Time of Change"

Passed Recommendation:

Consider an item related to request to update the pamphlet "A.A. for the Black and African-American Alcoholic": The committee discussed the 2020 Conference

Committee on Literature's recommendation that the pamphlet "A.A. for the Black and African-American Alcoholic" be updated to include fresh stories and a new title **that is respectful and inclusive**, noting that this item did not receive enough time for a vote during the abbreviated 70th General Service Conference. The committee also discussed the placement of this item on its agenda as a result of a 70th General Service Conference Floor Action and subsequent forwarding of the item from the trustees' General Service Conference Committee to the trustees' Literature Committee. The committee discussed that the recommendation and Floor Action were both impacted by agreed-upon procedures adopted for the unique, abbreviated 70th General Service Conference. The committee agreed that while the recommendation was not voted on at the 70th General Service Conference, significant support was present for the pamphlet to be updated. The committee noted that the pamphlet in its entirety has not been updated since 2001. To inform discussions on the possible updating of this pamphlet, the chair appointed a subcommittee comprised of Nancy M., chair, Mike L., and Amalia C. to:

- **1.** Explore what approaches might be most effective for reaching out to foster significant amounts of submitted stories for when the pamphlet update may be approved.
- **2.** Gather shared experience to inform discussions for updating stories and making the pamphlet as relevant as possible.

Trustee's Literature Committee Actions:

Consider updating the pamphlet "A.A. for the Native North American": The committee considered
this request and noted the need for an overall update including <u>ensuring that the language is</u>
<u>respectful and more effective at carrying A.A.'s message.</u> It was recognized that research
will likely be necessary for a comprehensive revision. The committee agreed to forward the item to
the 2021 Conference Committee on Literature.

1. Did not take action on:

Consider returning to the practice of not changing Bill W.'s writings: The committee discussed this request and took no action. The committee noted that past advisory actions reference not making changes to certain writings of Bill W. and that editorial practices as well as **past advisory actions have resulted in certain changes to other portions of Bill W.'s writings.** The committee also noted that the group conscience of one Conference is not binding on another.

0. An Advisory Action was made:

A revision be made to page 117 in the book, Twelve Steps and Twelve Traditions, replacing the phrase "opposite sex" with the word "partner" as follows, and **that a footnote be added** to provide context to the change as it relates to inclusivity:

Other points to consider:

"Join the Tribe" from personal stories was not carried over to the Fourth Edition of the Big Book.

Spokane Districts Revive the Monthly Potluck/Speaker Meeting.

Years ago, the Central Office sponsored an all-city potluck/speaker meeting on the first Sunday of every month at the Alano Club. It was an open meeting for AAs all over Spokane, Spokane Valley, and outlying areas. The purpose was strictly fellowship and unity.

At that time, all the group reps met together as the Intergroup and signed their groups up to host one of the potlucks. Each group used their own meeting format so that we got a flavor of other meetings.

The Central Office paid for the venue, the coffee, creamer/sugar, etc., and the non-food stuff like paper plates, napkins, etc. A basket was passed during the meeting portion of the event to defray the costs incurred by the Central Office, so the event could be as self-supporting as possible.

When the board of the Central Office was reorganized about 8 years ago, local AA unity was fractured into 4 separate districts and the monthly potluck/speaker meeting went away. We want to bring it back! We want to reunite as a Fellowship here in the greater Spokane area.

The 4 Districts will co-host the first event. Eventually, we'd like to see groups from around the city sign up to host the potluck each month. The host would get the speaker and host the AA meeting, set up and clean up, make the coffee, pretty much the normal things we do when we have a potluck meeting.

The idea has been reviewed and approved by the GSRs/reps at all 4 district meetings. The districts have agreed to split the costs for this event. We want to raise a "seed money" for the event, a kind of a kitty, to pay for the coffee etc., the non-food items needed, and the venue. (Note: We've held two all-district events successfully so far.)

We have asked the Central Office if they would like to have a table to display and sell literature and other Central Office product.

Hopefully, this will be a regular event where Spokane AAs can get together from all over, see people they might not have seen in a while, and feel like a whole family again.




