Greetings Area 92!

Hello, my name is Ben N. I am an alcoholic; my sobriety date is February 21 2014. I gratefully serve as delegate for Washington State East Area 92, Panel 72.

My topic today is: "How to introduce General Service to the Fellowship, especially those members who feel negatively about G.S.O." I suppose the best way to introduce general service to the folks who have negative feelings about the General Service Office, would be to share my experience. In the spirit of "one alcoholic to another". I recall in the early going at my home Group business meeting, they were looking for someone to step up to the position of GSR. After the duties of GSR were read, one being, serve as the mail contact with G.S.O. An "old timer" with 30+ year's sobriety, who many looked up to, bellowed out: "the G.S.O. is nothing but a bunch of fat cats in 3-piece suits blowing our seventh tradition money!" (I was to learn much later our 7th tradition contributions are actually made to, and managed by the General Service Board). He went on to say our Group would be just fine without the General Service Office and the Trustees. That was my first impression of general service and New York.

When my sponsor agreed to work with me, she "suggested" I get into and stay in service, she said: "service is one third of our spiritual journey." Rather than commenting on that gentleman's opinion, she

suggested I investigate for myself what this was all about...I could never have dreamed what I was to discover. At my 1st assembly, I experienced an overwhelming, indescribable feeling of being where I was supposed to be. That was the beginning, and the feeling is still with me today.

As GSR, attending our Area election assembly, our Regional Trustee, Joel C., there to facilitate the election, offered this instruction: "before we begin, consider that while sobriety time and experience is important, what is equally if not a more important qualification is availability and enthusiasm, because we don't do this alone." That one statement removed from me any fear, reservation, and feeling of not being "qualified". I was available and I was enthusiastic... I must be qualified!

While serving as an alternate DCM and DCM, I began to get a glimpse of the larger picture of A.A. as a whole. It became apparent that carrying the message was worldwide, not just limited to Groups, Districts, and Areas. I began to understand the vital role of the General Service Office in the flow of materials and information traveling up and down our triangle. An A.A. presence can be found in approximately 180 nations worldwide.... Who knew?

While serving as Area corrections chair, it was suggested that all standing committee chairs contact their G.S.O. counterpart and introduce ourselves. Up to this point my experience with G.S.O was limited to receiving Box 459, a service position kit or an occasional email. Remembering what that old-timer had said about New York, I must admit that when the General Service Office Corrections desk answered the phone on the second ring, I almost fell out of my chair! I still had some lingering preconceived image of a lofty bureaucrat with not a whole lot of time for a corrections chair out in Idaho. Talk about "Contempt prior to investigation"!! I could not have been more mistaken. Diana L., who I would later meet at the National Corrections Conference, was knowledgeable, pleasant and eager to help me in my new position. Communicating regularly with Diana and other G.S.O. staff reinforced those words: "we don't do this alone"

After serving Area 92 as alternate delegate, my "spiritual journey" brought me to the 72nd General Service Conference. Walking into that big ballroom at the Brooklyn Marriott I was overcome by that same magical feeling of that first assembly. Over those six days, my eyes were opened to the dedication and love for Alcoholic Anonymous demonstrated by everyone there. The awe and appreciation I now have for our General Service Office and fellow conference members is difficult for me to describe. Experiencing firsthand the loving, tireless effort these folks put forth to support our Fellowship is something I will never forget. I am blessed with their lasting friendship. I thank God for my sponsor who

insisted that I "get into and stay in" this beautiful third legacy of service! Thank You

Hi everybody! Hope everyone is staying cool in this extreme summer heat we are having!

I am so excited to see that the Archive Motion to increase funding for a new repository was passed to be voted on at the October Assembly. The Archives Steering Committee has put a lot of work into making sure Area 92 has all the information needed to pass the motion. It is very important to provide a place where our archives will be safe from deteriorating due to temperature and humidity problems that are currently causing damage. We are one more step closer in making that happen. We have also had an offer to rent a facility in Hayden Lake Idaho and I had a chance to go out and look at it. It not only looks like it would work beautifully but the price at \$600 per month would be perfect too! This would be significantly lower than the estimated \$1500 limit we were asking for. I just knew that if we put out the word that we had a serious problem, that there would be an answer. Nothing is impossible in Alcoholics Anonymous. There is a lot more research to do but I am hopeful.

I have been continuing to catalog documents and just started my 21st content list box. This is significant because of the number of documents that need to be cataloged. It is a slow and tedious process removing staples, identifying documents and placing them safely in acid free folders and boxes. I have found some more bleeding documents and overhead slides. They must be lined with buffered paper to make sure they don't continue to destroy other documents next to them. I am hoping we get the new repository so we can slow the process down and save our history.

I have also registered to attend the National Archive Workshop in Little Rock, AK in September. This is the first workshop that has been available in person since I became WSEA 92 Archivist in 2020 due to the pandemic. I am hoping to learn a lot to help me perform my archive duties especially in creating Digital Archives. This is a huge project that is long overdue. With the prospect of a new repository within our grasp, where we can plug in equipment to digitize and scan with, it is time to get started. I am hoping to get a lot of information and with the help of the Archive Steering Committee will form a committee to get this project going soon.

2022 Ad Hoc Inventory Committee Report

Good morning Area 92, I'm Gary P. an alcoholic and a Past Delegate who served with the Pandemic Panel 70's. I am delighted to be here, even on-line. Observing and listening to our fellows is always deeply fulfilling.

I want to thank Benjamin for asking me to develop and work with a 2022 Ad Hoc Inventory Committee. At the time I agreed to do this, I was unaware that I would encounter just a few days later some pesky heart pump issues. These would derail me for several weeks. While the heart issues are not entirely abated, a couple of mildly invasive procedures and medications have allowed for improvement and I am now able to function better and to make a bit of progress. Many thanks are owed for the capable assistance and counsel of our committee members along with past Panel 66 delegate Scott R. I confess that a fair portion of what follows in this report was obtained by extracting text from AA publications and previous AA reports regarding general service inventories. In A.A., we benefit greatly from what we receive from others.

It seems to me that a solid understanding of the overall objective of the Service Inventory is crucial. In other words, why are we doing this and what is the desired end-result? And following that, what commitment in scale, resources and time is required to achieve the objective?

Let's examine the objective first. The content in the following couple of paragraphs is extracted from the A.A. General Services Conference Inventory – Compendium 2013 – 2015.

"Taking an inventory, in the best sense of the word, is a fundamental aspect of A.A.'s program of recovery. Bill W. reflected in A.A. Comes of Age (page 231), "Just as each AA must continue to take his moral inventory and act upon it, so must our whole society if we are to survive and if we are to serve usefully and well.

"An inventory, then, at the level of general service is a natural outgrowth of that which is done to maintain individual sobriety throughout the A.A. Fellowship. However, when applied to A.A.'s general services and for the purposes of the General Service Conference inventory, the "Twelve Concepts for World Service," not the Twelve Steps for Recovery, provided the lens through which to evaluate current Conference practices and procedures, to determine how they relate to the original plan, purpose and structure of the General Service Conference."

"Self-assessment is a pervasive part of our A.A. program; fully half of our Steps are directly related to it. Inventory of the Conference and personal inventory in the Steps are not quite the same, however. At the Conference, the emphasis will be on effectiveness in carrying out the purposes of the Conference, not on 'character defects."

"We don't take inventory simply because it is, in and of itself, a good thing (like kindness, or generosity), but rather because it is an important element of our continued sobriety. The same holds true for our service inventories, including the Conference inventory.... We are not here to take pride in doing the responsible thing by taking an inventory. We are here to help assure the unity and effectiveness of A.A. in its mission to carry the great message of hope to anyone, anywhere, who has a desire to do something about his or her drinking problem."

While this text is only a very small portion of the GSC Inventory Report, it clearly states the singular objective is to perpetually improve our ability to "Carry the Message". I can attest that the remaining 27 pages of the report are similarly focused. In last evening's report on the Warranties, Scott R. verbalized that in his experience as a delegate, the GSO and the Conference itself were fully devoted to A.A.'s Primary Purpose. My experience as a delegate with the GSO and the GSC was precisely the same.

Now, to the Issues regarding the scope of the commitment necessary to achieve the objective.

The previous quoted text was extracted from the introduction to the Final Report for the GSC inventory that encompasses 28, $8\frac{1}{2}$ X 11 pages, fully printed. The Inventory itself took 3 years, 2013 through 2015, to complete. When including the planning that was begun in 2008, the entire effort required 7 years. Clearly, this GSC

Inventory was comprehensive, covering 14 broad Themes (Topics), and 44 specific questions. Many questions were carefully composed in the context of an applicable Concept. Collectively, the 44 questions addressed a very wide range of General Services in direct support of practices and procedures that "Carry the Message".

In contrast and like most Areas, Area 92 has historically narrowed the scope of the Service Inventory objective to a more achievable and manageable scale. At the 2013 WSEA Assembly held in Pasco, a motion was passed that allows for a {2} hour Area Inventory Report during non-election October Assemblies. It begins at 3:00 PM on Saturday of that Assembly and is chaired by a Past Delegate. The inventory will contain {3} to {5} inventory questions which could come from any of the following: Home Groups, GSR roundtable meetings, DCM roundtable meetings or from the Area Committee. Unfortunately, this language regarding the inventory process is contained in the "passed motions" on the website and is not codified by any specific section or paragraph in the Area 92 Handbook.

Last evening, we asked for input from this Quarterly's (2022) GSR and DCM roundtables and also have 2 suggestions already submitted by the Area Committee. We agreed during the meetings to continue to accept additional questions until July 31st.

During August, the committee will combine where appropriate similar questions and begin the process of condensing the list. A key step in this process will be to rank the items in order of their potential benefit to Area 92, eventually selecting the top 3 to 5 questions based on that estimated benefit. We anticipate that this will be concluded by August 31st.

The committee will spend the month of September, assembling the inventory questions along with their respective background information, any applicable member commentary or recommendation into a final package that will be delivered at the October Assembly.

At 3:00 pm on Saturday, October 15th, at the October Assembly, a 2-hour session is scheduled to review and discuss each final question from the inventory. The Assembly has the latitude to choose any action it deems appropriate for each question.

Members who are interested in reviewing previous service inventories may find it informative and useful to review these two Inventories:

- 1. A.A. General Service Conference Inventory; Compendium 2013 -2015 (28 pages)
- 2. WSEA 92 October Assembly Inventory 2018 (8 sections 11 pages)

These have been placed on the g-suite Drive along with this 2022 Ad Hoc Inventory Committee Report.

In closing, the committee has discussed the need to develop a section in the Area 92 Handbook with the Handbook Committee that details the duties and responsibilities of the Ad Hoc Inventory Committee. Several paragraphs and sentences could be extracted from this report as a starting point. Our committee members are willing to assist the Handbook committee with this effort.

Hybrid Ad-hock Committee

The Hybrid Ad-hoc Committee presented our motion at the July Quarterly. The motion was approved to go to the home groups for the final decision, and our committee was given until the end of July to revise our background to better address the financial impact on the Area.

After fully discussing two thoughtful presentations by committee members, we revised the "financial impact" part of the background.

Financial Impact:

• This motion **on its own** does not have a financial impact.

This motion is simply deciding whether we want to continue doing hybrid Area Assemblies, Quarterlies and Standing Committee Workshops. There's no point in figuring out the cost of it if we haven't decided we want to do it. For example, before considering whether you can afford a car, you first decide whether you want a car at all. THEN you go look at your income and expenses and see what you can afford for a car.

• Cost of the virtual platform is already budgeted.

The Zoom license is not a line item on the 2022 Budget. The Area Treasurer says it is simply part of "Area Expenses."

THE FOLLOWING PHASES LAY OUT THE PROCESS CLEARLY AND SUCCINCTLY:

- **Phase 1** Do we support the reasons to make hybrid format a permanent part of the Area meeting?
- Do we want to do this at all? This is the necessary starting point and the ONLY point of the motion under discussion.
- **Phase 2** Completion of specifications and cost/budget for implementing the format. IF we decide we DO want to do this, what will it take to do it well? The Technology Committee will answer that question. It is their area of expertise and their responsibility. It would be a waste of time addressing this issue if we decide we do *not* want to continue using hybrid format.
- Phase 3 Additions to the Area Handbook and Hosting Guidelines for hybrid meetings.

Again, IF we decide we want to continue using hybrid format, THEN, based on what the Tech Committee says we need to do, we would update the Area Handbook with a statement of intent to use hybrid format and certain job descriptions for those trusted servants who have something specific to do with the hybrid format. The How to Host booklets, while not on the same authoritative level as the Area Handbook, would be updated to guide hosting districts on how to work with the Alt Chair and the Technology Committee with regards to hybrid format.

The motion now belongs to the Area. Members of the Hybrid Ad-hoc Committee can answer questions and offer further clarification. Contact the committee chair at dcm2@area92aa.org or 509-279-5640. Committee members are also available to address districts or groups as needed. However, our intent was to present a complete and clear enough background that further explanations would be unnecessary.

Area Registrar

At this time the dashboard is showing we now have 478 groups registered and 5 virtual groups. I was asked by a DCM to make about 17 groups inactive as they no longer provide meetings.

I'm repeating what I said last month when I reported that I reviewed the Area 92 meeting schedule on the website and there are approximately 160 meetings listed as online. This includes those both hybrid and online. If your meeting has changed and is no longer online, let me know so they can be changed back to in person only. If any of you want your meeting registered with GSO as online please let me know.

Also, if your group was made inactive during the pandemic and your DCM has not made it active, please let me know so we can get it updated.

If you have any questions about the status of your groups, please contact either your DCM or myself, as we would like to help you with any questions. DCMs do have access to the Fellowship Connection to review reports. If there are changes to be made, they should contact me and I will attempt to make the changes. If I can't, because I don't have access to them, I will notify GSO members services to make the changes.

Current Motions in Process

HYBRID AD-HOC COMMITTEE MOTION #1

The Hybrid Ad-Hoc Committee moves that Area 92 use hybrid format for Area Assemblies, Quarterlies and Standing Committee Workshops.

What will happen if this motion is adopted:

Accessibility:

- It makes it easier to attend if a meeting is a long way from a group or district. Hybrid meetings allow for ongoing engagement when physical attendance is not possible.
- Gives everyone a choice to attend in person or virtually without denying anyone access. Closed captioning allows people with hearing impairments to be able to participate better.
- Affordable option for groups that are not able to pay for the cost of travel and accommodations.

Inclusion:

- Hybrid format facilitates the right to participate.
- The more people involved, the stronger the voice of AA as a whole.
- With more participation, allows for a broader group conscience.

Unity:

- The more we engage, the better we understand each other.
- Increased communication between the groups, the Area, and AA as a whole. Cost savings:
- Districts and groups with limited resources can still participate.
- Recording, required per the Area 92 Handbook, is included in the virtual platform. Changes to the Area:
- The Hybrid Ad-Hoc Committee will work with the Handbook Committee to draft changes to the Area Handbook and "How to Host an Assembly/Quarterly" and present them to the Area.
 - Technology Committee will create training for Standing Committee Chairs. Financial Impact:
 - This motion on its own does not have a financial impact.
 - Cost of the virtual platform is already budgeted.
- Phase 1 Do we support the reasons to make hybrid format a permanent part of the Area meeting?

- Phase 2 Completion of specifications and cost/budget for implementing the format. Phase 3 Additions to the Area Handbook and Hosting Guidelines for hybrid meetings. What will happen if this motion is not adopted:
 - Hybrid will still be an option but there would be no protocols in place. Inconsistent application of hybrid format could continue on a case-by-case basis. The people who have been able to attend because it was virtual may not have that access anymore.
 - Therefore, we may lose participants.

Embracing the technology of today we are investing in the future of carrying the message to the still suffering Alcoholics.

Archives motion:

The archives steering committee moves that Area 92 increase funding, not to exceed \$1500/month to enable the repository to be moved to an appropriate location in the Spokane area on an experimental basis of 5 years.

BACKGROUND:

WSEA 92 decided to have a permanent repository in the Spokane area eight years ago. A temporary location in Airway Heights was found that was considered "climate controlled" by the facility. The previous and current Archivists have both found that this facility does not meet the requirements as stated in the GSO Archive Workbook (about 70F and 45% humidity). Nor does this facility meet the guidelines suggested for a repository. The archives need to be accessible and allow for the interaction of our fellowship with the history that is stored there. This "living history" is how the archives pass information and keeps our historical facts accurately recorded.

Due to the current storage temperatures and conditions, suitability and parameters are not being met and documents are deteriorating. In December of 2019 a hygrometer, which measures temperatures and humidity, was placed in the facility and has validated why the collection is in decline. This means that we are losing our history in real time. It is imperative that we locate a new repository so we can house our collection SAFELY and perpetually.

Presently we are spending \$288 per month for 2 storage units approximately 300sq ft. total which is insufficient for the amount of items coming in. The current repository makes on-site cataloging of the estimated 75,000 or more items extremely difficult without electricity and wi-fi being available for computers and printers, nor is it possible to adequately set up future equipment to digitize the collection. Currently we remove items to catalog which places them at risk of loss and/or damage.

The Archives Steering Committee has done research on the leasing of a commercial space for a repository in the Spokane area and would like to share our findings with the body. In the hope that this information will help clarify the expenses we will incur with the motion's passage, here are some of our findings on the matter: Commercial property is leased in numerous ways, as one can imagine, so here are some of the options: triple net, double net, gross lease, modified gross lease and all of these methods address the costs of leasing a commercial space either by bundling all the costs of the property into one payment or having the lessee pay taxes and utilities separately. In the final analysis the payment will be the same. The lessor is also responsible for liability insurance for the property. If we are responsible, then we are the lessee. I the building owner is responsible then they are the lessor.

In speaking with property management professionals, the \$1,500 per month seems to be a workable number to cover all expenses for our needs and it should be noted that these numbers apply to Spokane. Some owners require a deposit and first month's payment, and a lease agreement is a [1] year commitment and can run up to [5] yrs. with clauses to adjust payment amounts as per economic conditions.

To sum up the above information: we will be responsible for the payment for the property, taxes, utilities, liability insurance, Wi-Fi, etc. Savings might be possible if we were open to a basement property or a non-ADA accessible property so there are a lot of options.

The Steering Committee will agree to the size, location and suitability as described in the Steering Committee guidelines.

We have located a facility in Hayden, ID that would possibly meet our needs. Rent being about \$600 per month including utilities.

Examples of what other areas pay as follows:

Area 72 rents a 1400 sq. ft. commercial property in Stellacom Square, Lakewood, WA for \$1,494.55 per month, including utilities and Wi-Fi.

Oregon 58, rents a garage-sized Repository something like 30'x30', maybe more. Rent is \$915 per quarter, or \$3,360 per year. It is located in an out of the way town at the edge of the state.

Southern California Area 05 rents a public storage facility for approximately \$130 per month.

A new repository will also provide an area to catalog items on-site, provide hands-on training opportunities to new archivists and volunteers on how to catalog and store our collection safely.

The purpose of this motion by the Archives Steering Committee is to be able to fulfill our responsibility not only as the Archives Steering Committee, but as an Area to protect and preserve archival materials in a climate-controlled repository as stated in our Area handbook under 8.2.2, Archives Steering Committee duties.

If this motion passes it will give the committee the flexibility to secure a repository at the monthly cost of \$1500 or less and will give us the ability to control the environment and do the archival work necessary to preserve and protect Area 92 history.

Bill wrote: Concerning any given service, we therefore pose but one question: "Is this service really needed?" If it is, then maintain it we must, or fail in our mission to those who need and seek A.A.

We believe that if we ask our Home Group members, "do they want our history preserved?" Their answer will be yes, we want and need our history.

Frequently Asked Questions About the 2025 International Convention & Travel to Canada Updated July 12, 2022

When and where will the 2025 International Convention take place?

The 90th anniversary of Alcoholics Anonymous will be celebrated at the 2025 International Convention in Vencouver, BC, Canada, July 3 – 6, 2025.

2 What is the theme of the 2025 International Convention?

The theme of the 2025 International Convention is "90 Years - Language of the Heart."

Have A.A. International Conventions been held in Canada before?

Yes. There have been International Conventions in Toronto (1985), Montreal (1985), and Toronto (2005). As you may know, the Responsibility Statement was adopted at the 1985 International Convention in Toronto.

4. Are there any restrictions or regulations affecting travel to Canada in 2025?

Yes. The U.S. and Canada each have restrictions and regulations that apply to citizens and visitors who travel from one country to the other. Border crossing into Canada has significantly changed, particularly in the last two years. (For more information: access links to Canada Border Services Agency website (CBSA) provided below question #6)

Who will have to process forms and applications to gain admission to Canada?

It is suggested that those who believe they have some past legal incident, such as a DUI or felony that could inhibit their attendance at the 2025 International Convention, seek assistance/information by accessing the CBSA links provided below question #6.

6. What Canadian travel information is currently available?

The International Convention assignment at G.S.O. is not yet up-and-running. However, below is a resource to aid members in making plans to attend the 2025 International Convention (most questions can be answered by connecting to the links below). Also, a good travel book on Canada will provide valuable information on needed documents and border crossing requirements, as well as vacation tips.

When will registration and hotel information be available?

General registration and housing information will be available on the International Convention webpage in early 2024. Actual registration site links, forms, and hotel booking links will be communicated to the Fellowship in August/September 2024.

If travel to Canada is difficult for some U.S. members, why are we holding an international Convention in Vancouver?

The Fellowship of the United States and Canada makes up the General Service Structure of Alcoholics Anonymous in North America, and functions as one entity in spirit and in service to the Fellowship. As this event rotates through the regions of A.A., there will be times when it takes place in the U.S., and other times when it is held in Canada.

Laws and other circumstances may impede some members from traveling from one country to the other. For instance, some Canadians could not attend the 2000 International Convention in Minneapolis because of the difference in value of the Canadian dollar and U.S. dollar. Rotation of International Conventions provides accessibility for all members. The Metro Vancouver Convention & Visitors Bureau has assured A.A. that Canada will do whatever is possible to welcome and cooperate with members for the 2025 International Convention in Vancouver.






