The Technology Committee has been meeting on a biweekly basis. In addition to gaining a thorough understanding of the costs associated with acquiring and maintaining audio-visual equipment, we have also developed a system that is compatible with most facilities and staffed with trained personnel to ensure smooth operation. Our goal has been to create a seamless online and in-person experience while also efficiently conducting AA business. To achieve this, we have experimented with borrowing equipment and evaluating different options based on cost. However, we have found that the cost of renting audio-visual equipment from facilities has become increasingly expensive. As such, we are in the process of writing a motion to fund the Technology Committee for the AA Area, which will result in cost savings for the Area.

In February, we will be offering a Google Workspace training session for DCMs, Elected Officials, Standing Committee Chairs, and Delegates. We are also working on improving our translation capabilities for our hybrid model and plan to collaborate with the Translation Committee to test various methods for allowing translators to participate online during Assemblies and Quarterlies.

Our website, area92aa.org, is full of useful materials for all AA members. We encourage you to check it out.

I am grateful for the opportunity to work with such a talented and dedicated group of AA members who are generously contributing their time and skills to improve AA. Thank you for this chance to serve."

Proposed Motions

HYBRID AD-HOC COMMITTEE MOTION #2:

In the event of an emergency, the Chair, Alt-Chair, Delegate, Alt-Delegate, Treasurer and Alt-Treasurer together are tasked with and authorized to make a decision for the good of the entire Area on how the Area will hold an Area Assembly, Quarterly, and/or Standing Committee Workshop.

The Area Chair will lead the decision-making process in compliance with AA Traditions and Concepts.

For the purpose of this motion, an emergency is defined as A) a far-reaching event or condition presenting a high potential for risk to Area event participants, or B) an irreplaceable loss of a venue.

BACKGROUND ITEMS:

"An outstanding characteristic of every good operational structure is that it guarantees harmonious and effective function by relating its several parts and people in such a way that none can doubt what their respective responsibilities and corresponding authorities actually are. Unless these attributes are well defined; unless those holding the final authority are able and willing properly to delegate and maintain a suitable operational authority; unless those holding such delegated authority feel able and willing to use their delegated authority freely as trusted servants; and unless there exists some definite means of interpreting and deciding doubtful situations—then personal clashes, confusion, and ineffectiveness will be inevitable." *12 Concepts for World Service, page C33*

Currently, the Area Chair is "responsible for the smooth running of Area Assemblies and Quarterlies." *Area 92 Handbook page 10*. The six (6) elected trusted servants are chosen by the voting body of Area 92. They create a group conscience, a balance of a wider variety of points of view, through which the "one ultimate authority," *Tradition 2*, is expected to express itself. It also protects the one person already tasked with guiding Area business from being singled out for push-back. It is more effective to work as a group, both in the quality of inner guidance and of handling questions and doubts from the membership.

Assemblies and Quarterlies are Area 92 business events. In an emergency situation, decisions made on behalf of Area 92 ought to be made by the Area Trusted Servants.

Having six people making up the group conscience provides perspective and thoroughness of the decision.

Primary Benefits:

- It's important to have a process for handling emergencies.
- Provides transparency on how an emergency decision would be made.
- Protects the Area membership's safety and welfare.
- Provides continuity for Area business in the event of emergency.
- Provides direction for the Area trusted servants that are already tasked with making sure Area business is conducted.

What happens if this motion passes:

- We have a policy to implement in the event of an emergency.
- The Area 92 Handbook and the How To Host booklets will need to be updated.

What happens if it doesn't pass:

- We don't have a policy to implement in the event of emergency.
 - Decisions might be made, or not made, to the best of the ability of the Chair alone.
 - Without a guideline for prudent thought and action, we would have chaos, costliness, and strife. It can be very expensive to just react.

Except in unusual circumstances, additional funds sent to GSO by WSEA 92 generally go toward the actual cost of delegate registration for the Conference.

The Finance Committee feels the word “audit” can seem a little scary and can create a fear of possible punitive action. An audit always requires the committee chair and all members of the audit committee to sign the final audit report. The requirement for this is already stated in the WSEA 92 Treasurer job description and applies whether we use the term “Financial Review” or “Audit”. We feel the term “Financial Review fits in better with A.A.’s Twelve Steps, Twelve Traditions and Twelve Concepts for World Service.

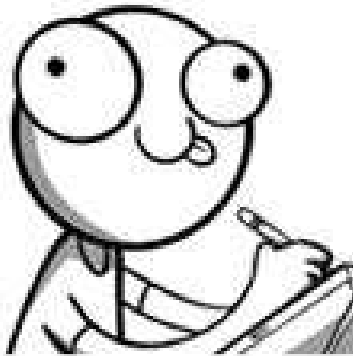
