WHEN AMAZING THINGS HAPPEN

I have a regular meeting that I attend every Tuesday. It's about a 40 minute drive but I enjoy the people and the fact that they choose a reading then discuss alcoholism. This week, due to challenging weather, I was unable to attend but decided to take the drive on Thursday. I had already completed my 11th step readings and felt compelled to go, even though I'd never joined them on Thursdays. When I walked in the room, I was surprised to find about 30 men with one woman who was chairing. Shortly after, a young man walked in inquiring whether this was AA; we all responded "yes, have a seat". How It Works and the Twelve Traditions were read and a fellow with 9 years started sharing and the miracle developed. As each man talked, there arose a comradery that filled the room, speaking to the newcomer. Continuing around with the male perspective, I could feel an air of excitement that I hadn't felt before; this was truly the magic of the AA message. Bantering back and forth, the friends told humorous and serious bouts with alcohol. The meeting was unfolding exactly the way the Higher Power wanted with no female interaction. It was very moving and I could see the face of the new man; he was hearing, and probably feeling, exactly what was needed. On my drive home, I thought about "a fellowship of men and women" and knew that explanation had been shown in that meeting; I don't believe the power would have been there with women also sharing. We do have to agree that they present their stories differently. I attend, many meetings both mixed and women only but, was thrilled that the Higher Power showed up exactly when he was needed.

Not to say there is an imminent crisis, but there is a looming shortfall of around \$10,000 per year. Right around 20% of current contribution levels.

This means unless contributions trend upward by about 20% of current rates our ability to carry our message to the suffering alcoholic will eventually be jeopardized.

I find myself in the awkward position of asking for more money, but I'm fairly certain that is exactly what is expected of me.

None of this is imminent and exactly why I am mentioning it. But as your "canary in the coal mine" I am chirping about it now.

We are working on strategies to make it easier for our elected and appointed to create and modify content on our website area92aa.org. Google Workspace: The usage and productivity of Google Workspace is being more used by our service workers. The committee suggested implementing additional training for members to ensure optimal utilization of this platform, particularly with regards to collaborative documents and data management. Dave G. was our guest speaker at the May Hybrid Ad hoc Committee meeting. This was our final consultation.

Dave's input: Our trusted servants must have the power and ability to do what has to be done to keep the Primary Purpose message flowing. Diana and Gary consulted people. Some people felt they should have been consulted or consulted more specifically. Some people are afraid that the trusted servants might exceed their delegated authority.

At this point, Dave left us, and the committee discussed what we want to do next.

We agree that we will do a report, rather than make any motion. In retrospect, we were trying to solve a problem under old circumstances, as though we don't have online capabilities and hybrid Area meetings.

Rainey will synthesize the minutes of our meetings in a Google Doc and invite everybody to comment. Then next month we can fine-tune it. We don't need to present anything at the Quarterly, only at the October Assembly. Naturally, an advance copy will go to the Area Chair.

Area Registrar

As the Area Registrar my responsibility is to register the groups and GSRs, contacts and other positions for Area 92. DCMs have been very helpful in letting me know when a group elects a new GSR and provides me with their name, mailing address, email and phone number. Once I receive this information I add it to the Fellowship Connection database so the GSR will start receiving their GSR packet along with information from GSO to help keep their group informed.

I continue to attend the Area Registrar zoom meeting on the first Sunday of each month to be kept up to date with any and all information. We have been experiencing a few changes in the registration process in Fellowship Connection at the General Service Office. One change is when adding a new position we previously were able to add an end date and the information about the individual would drop off the system after 2 years. Well, now GSO has decided they want to discontinue the end dates and retain the individual's information in the database.

So, to keep things up to date they are sending us a list of GSR's that will be dropped at the end of each month. I am to contact the DCM of that group and request updated information. If there is not a new GSR assigned the group will not receive information from GSO. If you as a DCM have groups without GSRs in order to continue to be on GSO's mailing list we need to add either a new GSR or a contact person so there is a current mailing address. We do not want a group to be uninformed due to having a GSR position expire.


