## **Area Alternate Delegate**

This is the presentation I did at PRAASA on "Service sponsorship – Are we effectively passing on our experience?"

Hi, I am Dan, an alcoholic.

My sobriety date is January 10th, 1979.

I am the new Alternate Delegate for Washington East Area 92

A good definition of a Service Sponsor is in the pamphlet P-15 Questions and Answers on Sponsorship.

It says:

A.A. "service" is anything that helps us to reach a fellow sufferer. Much the way A.A. sponsors share their experience in recovery with their sponsees, a "service sponsor" can be defined as an alcoholic who, having made progress in recovery as well as participated in service, shares this experience with another alcoholic starting their own journey in service. Service sponsors are

usually knowledgeable in A.A. history and principles and have a background in the service structure.

First let me do a 9th step on my prior actions that have interfered with GSO's ability to keep AA members in charge of our fellowship.

1. As a GSR

1. I would not attend District meetings because it seemed boring and I would make judgments about what is important to share with my home group. It helped me and home group members to stay uninformed.
2. I would bad mouth the process when I didn't agree with decisions made or upset with how long the process took

1. As a DCM

1. I only focused on getting committee chairs in place and didn't participate in Area or GSO activities
2. I helped my entire district stay uninformed.

1. As a Area technology chair

1. I would get frustrated with lack of trust to spend money for technical projects by people who acted just like me.

1. As a new Alt-Delegate, I hope I do better.

I have seen the consequences of these actions. I have witnessed Old-Timers discourage new people from service. These Old-Timers are not dry drunks but 12 step working members of AA. They have just not participated in the third legacy or given up on it. I have seen newcomers thrown into service positions because no one else wanted to do the work. This would be fine if experienced members sponsor them. I know members who believe that AA is not going to make it because of rumors and conspiracy theories.

So how do I make amends for these actions?

When early in sobriety, I thought that saying I was sorry was enough. I slowly learned that it also meant a commitment to not do the harm again. I used to be a pretty good athlete because I concentrated on my failures and used fear to try to never make mistakes again. It didn't work and mostly what I remember from athletics are my failures. The 12 steps showed me another way. This fellowship needs my best efforts at working with the solutions defined by the inspired structure left by our founders. A structure that can stay current and responsive to the still suffering alcoholic whether they be newly sober or long time sober.

My first sponsor told me the best way to help others stay sober was to stay sober myself and allow others to see that. No talk about how wonderful being in service is or talk about the wonderful people I get to meet, will ever mean as much having a purpose and being effective through power given to me through this fellowship and my God. What first drew me to service was getting to know members that were doing service work. I saw that they had a deeper purpose in helping the still suffering alcoholic.

So let's all do our best to be informed and help others to be informed so when we pray and meditate we can hear, feel, and experience the will of God in this very important work.

## Area Chairperson

In a late tragic development, we have lost one of our own in an automobile accident returning from last weekend's 2024 PRAASA in San Francisco. Polo, DCM for District 21 was killed and several other fellow PRAASA attendees were injured in the same accident. Deepest condolences to the friends and family of Polo, our thoughts and prayers go with them.

This is my report prior to this tragic accident:

It's zero dark thirty on Thursday morning and today I travel to the Pacific Regional AA Service Assembly (PRAASA) along with at least several other Area elected and various servants. This one is in San Francisco and across the bay sit Alcatraz and San Quentin. Several years back I got clearance and visited the AA meeting at San Quentin (Alcatraz is a museum now).

For those who don't know, prison meetings began when AA was only 7 years old. In April of 1942 then Warden Clinton Duffy called the Alcoholic Foundation (there was not yet a GSO or AAWS) and said something like "If the Alcoholics Anonymous program can save just one man, I want to start it". Six months later in September of that year several prisoners at Washington State Penitentiary (WSP) or "Concrete Mama" had their own meeting and laid claim to the 2<sup>nd</sup> oldest prison AA meeting. Today the Pioneer group still meets every Saturday at East Complex with the help of area corrections volunteers.

Our Area is currently collaborating on a bid committee along with several servants from Area 72 to bring the National Corrections Conference (NCC) to Tri-Cities and WSP in either 2026 or 27. Thanks so far to the participation of our standing committee chairs Dale and Lorri and past corrections chair Marc Mc as well as Adam P we are planning to present a bid at this year's NCC in Charlotte NC. I am optimistic we will be successful and very much looking forward to it. We have such good people, and one main purpose of this conference is to add more corrections volunteers just like them. I can't think of no better way to promote this needed service.

I will be taking a pile of flyers/registration forms to PRAASA for the Pacific Northwest Conference (PNC) coming to Wenatchee in June. This conference has its own rich history, being the oldest in AA originating in 1948 with the cooperation of none other than Bill Wilson. Hope to see many of you there.

Most of us are also preparing for the flurry of activity that always precedes our Delegate's trek to New York and the General Service Conference. There are both virtual and in-person Standing Committee Workshops this month that will be integrated and coordinated thanks to our capable tech committee. Everyone be prepared for this flurry of activity as Lisa will be seeking direction in our upcoming Pre-Conference Assemblies in April just prior to her trip to NYC and the Conference.

Cut to Sunday and now waiting for my flight back to Sea-Tac. Another PRAASA in the books and finishing up my report. Got to see many old and new friends and others at this well attended, coordinated, and fruitful event.

There were too many highlights to go into here but at least a couple takeaways from the various discussions: The Plain Language Big Book is on people's minds and will also be a topic of the upcoming General Service Conference. There was also discussion of virtual meetings and how better to incorporate them into the mainstream (or something to that effect). Virtual might not have been everyone's choice, and I wouldn't claim it's better than in person, but no one can argue it's not making AA better. Another topic covered that I have already mentioned is the pervasive shortage of members getting involved in service and ways to help address this shortage. Passing this along for the body to process and help us find solutions.

With Alt-Delegate Dans help I recently forwarded our equipment bid list to the National Corrections Conference Advisory Board (NCCAB) for reference as they are considering purchasing their own hardware to augment the capabilities of the NCC events. While our own area took this step last year many other areas are still in the process of going virtual.

Getting ready to board my flight now so I'm going to wrap this up for now. Looking forward to seeing many of you at the upcoming SCW and Yakima Pre-Conference Assembly.

RIP Polo, and blessings to all others who may be suffering at this time.

## **Area Treasurer**

Greetings from your WSEA 92 Treasurer's Desk.

It is a busy time of year. This month's primary focus has been on preparing the 2024 Annual Budget. As with everything in service and life there are always interruptions to the best laid plans, so the budget remains a work in progress that I spend time on when I find the time. Now I am working with our Alt Treasurer and Delegate on reviewing and preparing the GSC Finance Committee Agenda items for distribution. Our Delegates share to attend the General Service Conference has been paid. This year the amount was \$2200.00, which amounts to 24% of the cost per person (\$9,200.) the balance of which is covered by GSO. The Area Elected Officers and Standing Committee Chairs are registered for the Pre-Conference Assembly and hotel reservations are made.

As a member and Facilities Chair of the PNC Committee, I finalized the contract with the Red Lion in Wenatchee, and Executive Chef, the Caterer. Jan H, a member from my District, District 5, has graciously volunteered to decorate the tables for PNC and she is providing decorations and flowers at no cost to PNC. She said she is happy to have "the opportunity to give back". This woman has decorated tables for all of the functions our District has hosted and she does a first class, professional job!

Now down to business. Please review the following Treasurer's report of cash on hand reflecting Income and Expenses that came through the checking account at the end of February. We have a Prudent Reserve balance of \$2500 in Savings. I will send out the February 2024 - 2023 Comparison Statement of Activity (P & L) to DCM's, Alt. DCM's Panel 74 and our Past Delegates. I want to point out the difference in contributions between February this year and last year, which almost doubled this year! I am encouraged by the body's response to the financial need we are experiencing during this period of rising costs. We ended February \$1125.18 to the good. Let's do that again in March.

It all begins in the home group. One dollar simply doesn't go as far as it once did. No longer

does a buck buy a beer or a cup of coffee. It's time we rethink our contributions to the basket in our meetings. Just as the Area's costs are rising, so are our home group's. The cost of coffee alone has increased 56% since 2017, when I came into the Program. So goes creamer, sugar/sweetener, snacks, and the rent for your meeting space. Just a little food for thought!

  - B. The *Audit Committee Guidelines* we have now come from Dolores. Finally, someone wrote down what to do and how to do it! Another benefit of having Audit Committee Guidelines is that they will give the Treasurer a clear understanding of what will be needed for the audit.
6. Contributions: I have been picking up the mail and depositing contributions weekly. Our mailbox is in a UPS store. I hope everyone enjoys it. I have been working on a beautiful Pacific Northwest Conference display that has 1948, 1949 and 1950 minutes and a 1968 schedule that Jan and Fran P. donated from some of the earliest conferences that are amazing to see.

I have also been working on setting up WSEA 92 Digital Archives. This is a complicated process that I have been getting expert help with. There are some problems with Google in regards to searching but I am working out the kinks to make sure the final product will work to the utmost benefit to finding any item in both the digital index and our physical cataloged index.
