1. <u>PayPal</u>: Identifying source of contributions as a member of the Fellowship – I've asked the Technology Committee if they can insert a pop-up form between the Area website and the PayPal website asking the user to confirm that they're a member of AA. This form would generate from the Area 92 website and the user could not go past it without selecting yes, no, or cancel.

When you contribute through the Area 92 website, you will see a plus sign next to "Add special instructions to the seller." Click on the plus sign (+) to put in your group name and city or group number so the correct group gets the credit for the contribution. #### **Area Corrections Chair**

Hello Area 92!! 1 Apr 2024

Busy time of year for our Area, all these agenda items, SCWs, Pre-Conference Assembly!! Its hard to believe that above all that, we still can move forward in our respective Committees, but yet, we do! Since our last newsletters publication, your Area 92 Corrections world has been active on many fronts. Let's take a look at some of these.

In March a Corrections submission for the Area Newsletter was successfully sent in on time for publication. There were eight Corrections Committee Chairs & Liaisons positions filled, brining the total count to ten entities making up the Committee which supports all 16 of our active District Corrections Chairs and the Area 92 as a whole. Also, as Corrections Chair, I was able to attend both the online SCW and the Ephrata in person Workshop where we reviewed the Agenda Items. Great turn out for both. During the month we were able to Bridge another five releasing AA members either into our Area 92 or departing our Area 92 and heading off to other AA Areas around the country. This brings the total of persons Bridged so far this year to nine. Also just accomplished, an Area literature order was placed for the WSP.

Our March 2nd Monday Area 92 Corrections Chairs Monthly Online Meeting occurred on the 11th with an attendance of 13 people! We focused on getting registered with GSO and are eager to get the Corrections Kits mailed to each of the Chairs. Called for an initiative to identify each Districts jail facilities and if there is or has been an AA presence with them. Aim at getting some Corrections Correspondence Service F-26 forms out to each Districts Business meeting and to three meetings within each district. This is an effort to answer a call out from GSO for more volunteers to write with AA members on the inside. The AA Volunteer Coordinator, Tanya, for the WSP had noted that their roster of Volunteers to join meetings on the inside was needing more people. So, the neighboring Districts, 6, 7, 20, & 22 Corrections Chairs were asked to support by stepping up and spread the word of this need withing their districts.

But the highlight of the month for me was the reports given by each of the attending District Corrections Chairs at our monthly meeting, and with great pleasure I shall share this with you now! District Corrections Chairs Reports:

District 2 – Mary J. – Got \$100 of books to AHCC

District 13 - Mark A. - Currently figuring out his budget.

District 6 & 20 - Tabatha B. & Christina – Meeting monthly and being very active. Finally got approval at jail for meetings 1st & 3rd

Thur. In need of female volunteers. Contacted their juvenile court judge to see what they can do. Yakima county jail has both a men and women population. Bought some books. District 5 – Tom G. – Going to start up jail meetings on Mar 20th. They have 8 ladies and 9 men volunteers to attend weekly Wed meetings. They are holding off on getting literature until they can find out what, if any, inventory still exists from before covid. Also aiming at group homes, and juvenile facilities.

District 7 – Scott M. – Getting up and running. Ordering literature, daily reflections. Orientation in June.

District 3 – Troy J. – A ton of activity. AHCC groups wish to reengage newsletter submissions and guest speaker meeting events. Geiger correction center asked for a library of literature. When Troy mentioned this at a Central Office event he was asked to attend, he was presented with an anonymous \$300

donation to initiate it. Jennifer Hawkins is the Geiger poc and Troy is attempting to get a meeting started up in coordination with her. Volunteers at AHCC are currently getting to attend about 1-3 meetings a month.

District 12 – Pete H. – Thriving. There is a Thursday group that passes the Pink Can. Okanogan and Republic jails are beginning to come alive.

District 22 – Corey G. – They have two jails, one that meets weekly and one that meets two times a month. New staff that are working at the jail can be a minor challenge. Also having a monthly meeting with members.

District 8 – Leslie P. – Had a meeting with their juvenile probations officer along with Alateen and Al Anon. Will be having another meeting tomorrow. Still going into the jails four times a week. Facilities will

not participate in the Bridge program.
