#### **Area Chairperson**

The Pacific Northwest Conference (PNC) was a success and will skip next year (2025) as it's not held on International Convention years. So, the next one is going to be in 2026. My contribution this year was chairing the business meeting (per the handbook guidelines) and in spite of some parliamentary missteps on my part that were mitigated by our area people (and others present) who came to my rescue there were some important motions passed that should help the event going forward.

We have an area inventory every other year (this year) in October and after some discussion and consultation I have assigned Mark S to coordinate this effort. I am leaving it up to him to select his people and coordinate the effort. There will be more on this during our upcoming quarterly in Spokane.

Miguel A., our DCM for District 25 had previously brought to my attention some translation snafus (for lack of a better description) that resulted in translated language in the Area Spanish Handbook that was less

than ideal or even "offensive". I had discussed creating an ad-hoc committee to make recommendations to correct the language and after subsequent conversations it has been decided that a different translation software available (I think through GSO) will correct this language sufficiently. If so, there should be no need for an ad-hoc committee as the English version can simply be re-translated. My understanding is that this does not require a motion, only notification of the changes.

In a couple weeks a few of us will be traveling to Las Vegas (just prior to the quarterly) for the Pacific Regional Forum. I have only been to 1 or 2 of these previously but enough to know it's a very good exposure on what is going on at GSO and AAWS. Because this last year has been eventful to say the least, I'll be very interested to see what they have to show us and tell us about the condition and direction of AA as a whole.

I'm looking forward to seeing many of you the week after LV in Spokane at the quarterly. I mentioned in the DCM meeting (and other business meetings) my intention to better include younger AAs in our ongoing events, specifically a display table at our quarterlies and assemblies. The reception was positive, and it turns out there is an active contingent at least in the Spokane area. I'm hoping this initial effort will inspire additional cooperation and participation including volunteerism that may have been underutilized or perhaps not even thought of yet. Just reaching out to see what might happen. My expectation is something good.

We are one month closer to being able to register for the 2025 International. Pay attention and get registered ASAP in September when it opens as the housing is all tied to your registration. Just a heads up. It's all on aa.org FYI.

1. PayPal: Identifying source of contributions as a member of the Fellowship – I've asked the Technology Committee if they can insert a pop-up form between the Area website and the PayPal website asking the user to confirm that they're a member of AA. The www.aa.org website uses such a form. If the user confirms, great, they go on to the contribution page. If they say no, they get an explanation of our self-support policy. This form would generate from the Area 92 website and the user could not go past it without selecting yes, no, or cancel.

When you contribute through the Area 92 website, you will see a plus sign next to "Add special instructions to the seller." Click on the plus sign (+) to put in your group name and city or group number so the correct group gets the credit for the contribution. As always, when sending contributions by mail, be sure to put your group NAME and city or group number on it. We do accept contributions from non-registered groups.

- B. The *Audit Committee Guidelines* we have now come from Dolores. Finally, someone wrote down what to do and how to do it! Another benefit of having Audit Committee Guidelines is that they will give the Treasurer a clear understanding of what will be needed for the audit.

The Archive committee meets the 3rd Wednesday of each month at 6:30 pm. At our last meeting, we continued discussing the September 2025 Standing Committee Workshop. I am responsible for co-hosting this workshop with Jean L., DCM for District 5, in Wenatchee on September 20, 2025. The location has not been determined at this time but we are asking you to "SAVE THE DATE" and add it to your calendar as an upcoming event in 2025. The Archive committee has agreed to support and assist me in my duties at the workshop.

During our meeting, it was suggested that we have hands-on experience during our breakout session. If you are blessed with time, enthusiasm, the skills and knowledge necessary to train beginners, patience, love, tolerance, and a desire to carry the message of AA to the still suffering alcoholic, please reach out to me via email.

I was privileged to attend my first in-person Pacific Northwest Conference on June 21  $\sim$  23 in Wenatchee. During the event I hosted the Archive room, and set up WSEA92's PNC archive traveling display, together with Area 58 (Oregon) and Area 72 (Western Washington). We had a very large room and were able to display all that we each had from our respective Areas. I had the opportunity to meet James, Archivist for Area 58, Therron, James' assistant, and Maryland, Archivist for Area 72. It was a pleasure hanging out with them and learning more about archives. They were very knowledgeable and helpful. I learned a lot from this experience. We also had a laptop running throughout the event and many people who visited thought it was a great addition to the room. In my report at the quarterly, I will let you know how many visited the Archive Room at the PNC. Something I have to learn to remember to do is make a note of how many visited and know that information when I leave the event. Once that book goes back into the traveling display and is returned to our repository, I may not see it for months. The PNC archive repository is in Portland, OR and Area 58 brings the display to the event each year. The next PNC will be hosted by Area 72 from June 19 ~ 21, 2026. The traveling archive display is available for AA service functions attracting a general AA audience - beyond your immediate group. The WSEA92 Archives look forward to being a part of District activities and sharing our archival material. By actively displaying the Area Archives, we maintain our day-to-day experience in recovery and reach back for the shared experience from the past. If your District is interested in having the display at your approved AA function, please contact me for details.

In 2005, I attended my first international convention in Toronto, Canada. I am so grateful that I have the opportunity and ability to attend the **2025 International Convention from July 3 ~ 6, 2025, in Vancouver, BC.** On July 1st, I attended a Zoom meeting with AA members who plan on attending the convention. We have had a lot of excitement in Archives this month. We had an incident at the repository. There was a small flood, the plumbing backed up and a small amount of water entered our unit but **NONE OF THE ARCHIVES WERE DAMAGED.** The only items that were threatened were safely packed in individual boxes that were protected. Everything else was up on metal shelves and were also protected. Our hard work to safely prepare and store the collection is already paying off. I am taking corrective action to make sure that no items are left on the floor ever again and the ASC has taken protective measures for future emergencies should they happen. The last time our archives were threatened was by fire in Airway Heights in 2022. Luckily the wind changed direction and we were ok. These things are not good for an Archivist's blood pressure though. I am relieved everything turned out ok.

We had another productive Work Party on June 8th. Tom; ASC Member and Intergroup/Central Office President, Gabrielle; ASC member and Intergroup/Central Office & District 17 Archivist and Jeff; District 2 Archivist attended. We worked on preparing and cataloging the foreign Alcoholics Anonymous books and finished off 3 more content lists. We are making good progress. Thanks so much Tom, Gabrielle and Jeff! This was very timely and tedious work and I appreciate your service!

I have also cataloged the **Traveling Archive Display** creating 11 more content lists. This keeps track of items as they leave and are returned to the repository. I am continually adding new items to the display and although I don't get to be there in person, Michelle the Archives Chair is doing a great job putting up our beautiful displays both at the April 2024 Assembly and a small display at the Pacific NW Conference in June. I hope everyone enjoys them. Thanks for your service Michelle. And a big thanks to Allen Panel 68 Past Delegate who drives the collection to where it needs to be!

And I have an announcement! I have an idea that instead of having scheduled work parties we should have an open house every month. This way anyone that wants to can come and see the Archives, volunteer, or just hang out and see what we do. If every member in Area 92 came out once, a lot could be accomplished. We need you! ## Keys to Corrections



#### A Column to Inform and Encourage

Welcome to our second installment of what we hope to be a long running column of informative, encouraging, and inspirational topics from the wonderful world of service in AA Corrections. We welcome you to the... **Keys to Corrections!** 

Our headlining topic this month is what's often referred to as our "Bridge" program. This will be the first of two installments on this life changing program. The two-part series is halved at an inherent line between the inside AA Member, and the outside AA Member. And trust me, it is a life changing program for both parties. Out first focus will be on our inside Member, our Fellows behind the bars.

Our M45i Corrections Workbook introduces this program with a straight forward mission statement outlining the heart of the program, it states:

"Past experience has shown that attending an A.A. meeting on the outside on the day of release from prison is one of the most effective tools in making a sober transition and maintaining continued sobriety in the free world. It is strongly recommended that anyone in custody who is an A.A. member have an A.A. contact on the outside (preferably with at least one year's sobriety and of the same sex) who contacts and arranges to meet him or her on the day of release to help in "Bridging the Gap" between the institution and A.A. on the outside.

This section of the workbook deals with guidelines for A.A. members who want to participate in this type of service, sometimes referred to as "Prerelease" programs and sometimes as "Bridging the Gap" programs."

As you can see here even in our Workbook this program has an ambiguous name. This is due mainly in part to the Corrections Committee being a part of AA's original "Hospitals and Institutions" Committee or "H&I". Several years ago, this all changed:

"In 1977, the General Service Conference recommended that the Institutions Committee be dissolved and two new committees—one dealing with Corrections, and one with Treatment Facilities—be formed. The 1983 General Service Conference recommended that a Corrections Workbook be developed for carrying the A.A. message into correctional facilities."

Historically in the H&I days the efforts to get folks to an AA meeting as soon as possible from release of any form of institution was referred to as: "Bridging the Gap". After the spit up of H&I it was attempted to have these similar programs referred to as "Bridging the Gap" for treatment facility release, and "Bridge" for correctional facility release. This has been a source of confusion ever since. But our literature and brochures have tried to maintain their distinction. In recent times efforts have been enacted in what I see as an attempt to separate their names even further. By embracing terminology more in line with governing bodies of the institutions, we now have the referred to term of "Prerelease". Currently there is even discussion of embracing a newer terminology of "Reentry". Has there ever been a place where our Tradition 9's claim that "A.A., as such, ought never be organized..." has ever been more applicable??!! Rest assured, the heart and passion of our efforts at the mission of these programs is little hampered by such nuances, but when in conversation, let it be a heads up that you may hear its reference by different names, but the inference is understood. Currently our M45i Workbook, F-163, and F-162 forms/brochures are titled as "Prerelease" programs. Personally, I try hard to at least be consistent with the term "Bridge", somehow it has an essence of warmth to it for me.

What does the inside AA Member do? How do they begin their journey over this "Bridge"? Well, it actually starts with the outside AA Members. We provide the Form F-163 for the member to fill out. We do this in several ways; brought in with a meeting, provided with other literature, inform facilities where to download, or mailed in by an outside person. These are some of the standard ways. There are some critical

points mentioned in this form that ensure the greatest success in this program. One, the inside member must give us some time, thus it suggests that they complete and mail the form in six months prior to release. This gives snail mail time to reach us, secure a volunteer to contact them and arrange to meet and "bridge" the releasing AA. Today, our practice has changed a bit. Once we receive an F-163 form this rotation of your Corrections Committee has been able to embrace new technology. We simply get on the app of communication used with the inside members DOC provided tablet (Securus) and email them. Thus, immediate contact and dialogue is established. This has worked great for our Washington prisons. Jails though, do not have these tablets, and we have had no success yet this way with Idaho facilities either, so snail mail is still used for these and are our only means.

Now, I ask that you take a minute and place yourself in this position; You have been incarcerated for say fifteen years, and for the last ten years of that, you have found sobriety and attended AA meetings provided by outside members coming in. They bring experience, strength, hope, the Big Book, literature, and other materials. Among them you have occasionally heard about this "Bridge" program and some form to fill out. You see it occasionally floating around the facility. Maybe there is one that is all tattered and has nearly as much time there as you have. One day, about six months to your being released you find this form. You fill it out. You get to the end of the form and,,, there is a blank spot where you are to address and send it!

What do you do??!! Maybe you can find out from one of the outside members coming in, although dialogue is structured and maybe restricted. And they are not allowed to take material back out with them. Maybe you can send a letter to GSO. Already, this "Bridge" seems rocky and uncertain. But maybe you're lucky, and it seems firmer, for there is already a mailing address in this blank space. Thank you responsible hand of AA! You mail the form and eagerly await a reply. You wait, and you wait, and you wait. And your day of release draws nearer.

Trepidatious isn't it. If you take a look at the links and the F-163 forms they go to below, you will see that the form that is available for download from our website has our Corrections P.O. Box address already there. If you go to AA.org and download this form, it will be a blank space. When, as District 2's Corrections Chair, I went to supply Airway Heights Correction Center with some of these forms, I discovered this. I asked the GSR for their Landing Place Group if any of these forms were inside the facility already. I was provided with two blank forms mailed out to me. One form was actually an F-183, *Bridging the Gap* form. And the other a F-163 Bridge form which was an edition from 2016 or so, but it did have our P.O. Box address. In fact, and this is important, it was the same address we currently use. How is this you may wonder. This is because it is evidence of your 7th Tradition and Area 92 at work. It is the effort of your trusted servants and the couple of bucks you put in the hat, your Groups which participate in the service structure and do regular and consistent dispersants/splits of your choosing; Districts, GSO, Intergroups/CSO's. And in this case, your Area 92. I discovered that this P.O. Box had records of establishment at least as far back as 17 Oct 2014, and that the bill had consistently been paid. Thank all of you currently, and all that came before me. What a God send.

I will leave you all here, having filled out your F-163 form, mailing it in, and now waiting...

# Excerpt from the Grapevine article "The Sweet Smell of Coffee," from April 2020 written by Michael T. a person in custody:

"The been incarcerated almost 17 years now. I may never see the outside world again. I have good days and bad ones. But don't we all? I know I must continue to change. For me, sobriety is a gift that's earned every single day, just like most people earn a living on the outside world. Each and every hour, day, month and year that I don't pick up that first drink, I earn that gift.

# Dear A.A. Members,

In your area A.A. can arrange a Prerelease Contact for those soon to be released. If you are interested you can be matched upon release to an A.A. member in your home community.

This A.A. member will take you to A.A. meetings, introduce you around, and help you get

acquainted and comfortable in A.A.

Your Prerelease Contact is temporary only.

They are there to support you, answer questions, and explain the A.A. program of recovery. They will not provide housing, food, clothing, jobs, money, or other such services. You will hear suggestions for sobriety and will be introduced to basic recovery tools — like sponsorship, a day at a time, A.A. literature and A.A.'s Twelve Steps.

Past experience has shown that attending an A.A. meeting as soon as possible after release is key to making a sober transition to life outside prison. Many of us have been where you are and know that the program of A.A. and its fellowship can do for you what it has done for us and countless others.

Complete the attached Prerelease form and mail it to the address indicated. Please do this three to six months prior to your release. The Corrections committee will then match you up with an A.A. Prerelease contact in the community where you will be living. That person will write to you with information on how to contact him or her once you are released.

# A.A. Corrections Prerelease Contact Program Procedures

- As an inside A.A. member you are eligible for this program if you are within three to six months of your release date.
- 2. Please fill in the attached form and mail it to the Corrections committee. You will find the address at the bottom of the Application form on page 3.
- The Prerelease Contact will write to you to confirm contact. If the Prerelease Contact fails to contact you within a few weeks, you should write again.
- 4. You and the Prerelease Contact will set up a meeting at the time of your release. Please provide, on the prerelease form, such information as date of release, when you will arrive in the local area, and an address and phone number where you may be reached.


- The Prerelease Contact will meet you at an agreed upon time and place to help you adjust to attending your first meetings in the local community.
