I will be attending the Area 79 BC/Yukon election assembly in Victoria BC in September along with at least one other area chair (72), where I will assist with the vote count or any other duties they deem me useful for. I expect to gain information and perspective which will help me be a more effective servant.

Also several of our elected's and myself have been invited and will be attending the A72 election assembly in Tacoma in October to assist with their voting process.

Just about a week prior to our October assembly on October 19 we will be presenting a virtual workshop on parliamentary procedure Area 92 style. This is scheduled deliberately just prior to our assembly and open to all who wish to attend. I highly recommend attendance if at all possible as this is intended to help facilitate our business process and we expect to have a fairly busy agenda in October.

There is a new young people's AA (YPAA) meeting here in my hometown Yakima. This trend is encouraging and my intention is to help facilitate it wherever possible at our various events. I hope it's contagious!! I recently met with the associate superintendent at Washington State Penitentiary (WSP) in a bid to implement a virtual format AA meeting there, probably hybrid. This is being done nationwide in only a couple places that we are aware of but is a positive trend that I am hoping WSP will choose to get out in front of. He was receptive and I came away feeling positive about the chances to implement virtual there sometime soon.

The details will still have to be worked out. I told him and he agreed that virtual AA meetings (in correctional facilities) will be commonplace in the fairly near future. Because we have a bid committee formed and hope to bring the National Corrections Conference to Area 92 in November 2026 this would be a nice feature for our anticipated event.

Those interested in attending next year's International Convention July 2025 in Vancouver BC, Canada registration opens September 10 at 9am PST. FYI: Please note that all the housing is usually blocked for the convention, meaning that you can't get housing until you first register. It's nice that it is drivable for most of us but many with DUI convictions will not be able to cross the border into Canada. I think there is an 800 number at aa.org under the International Conference section to call with questions about your status on crossing the border.

Lastly, we discussed at our elections meeting that our contributions in the area are still lagging behind expenditures. Those groups and districts who are able please consider us (perhaps for a bigger piece of your pie) when you make contributions.

Area Treasurer

Greetings from the desk of your WSEA 92 Treasurer. I can smell fall in the air, my favorite season. Truth be known, I love all four seasons. In just a few short months I will be saying Winter is my favorite season!

When you review this month's Finance Report you will see our net income for August was -\$1,136.57. However, registration costs for the October Assembly were paid and a hotel room for Standing Committee Chairs was paid for, for those attending the Standing Committee Workshop in Libby, MT, September 21.

Our group contributions do not go as far as they once did and everything costs more than it used to. Could be a disastrous situation, but not for the tough resilient members of Alcoholics Anonymous on Area 92!

The 995 Challenge is doing GREAT! While our target contributors were intended to be the individual members in Area 92, the number of groups that are also participating in the challenge is an incredibly welcomed surprise.

Included with my Finance Report is a listing of all \$9.95-10.95, and some larger Individual contributions, received between July 20 and August 30. To date the total is \$1,014.98. The difference between the listing total and the amount of 995 Challenge Contributions reported on the Finance Report represents group and individual contributions not categorized as 995 Challenge contributions in QuickBooks. The finance committee will review the QuickBooks posting process at our next meeting.

What is our goal? GSO records indicate that Area 92 has 478 groups serving 6078 recovering alcoholics (YAY AA)! In theory, if all 6085 members made a one-time contribution of \$9.95 the total contributions would be \$60,545.75! Sounds terrific, but not realistic. We estimate that hopefully one third of our members will be able and willing to make this one- time contribution. Therefore, in keeping with our 995 theme and in celebration of the 35th anniversary of the birth of WA State East Area 92 (1995-2025), our goal is \$19,919.95. This amount equates to \$9.95 each for 2,002 members. With 25 Districts that is eighty individual (or group) \$9.95 contributions from each district. WE CAN DO THAT, right?!

So DCM's, please circulate the Challenge flyers and 7 th Tradition Fact Sheets throughout your Districts and be sure your GSRs are up to speed on this Challenge so they can share with their homegroup members. A copy of the Challenge flier is in the Newsletter.

We began the Challenge on Saturday at the July Quarterly and I think it would be fitting to end it on Friday January 17 at the January Quarterly. On Saturday, January 18 I will close my Treasurer's report with an announcement of the final grand total contributed. Finally, in celebration of our 35 th anniversary, we will all join in with a rendition of JHappy Anniversary to Area 92.

Fun/Happy times!!

Hello,

Regarding the 9.95 Challenge:

1) When we get contributions from individuals, they are entered under "995 Challenge" only. When we get contributions from home groups, they are entered under that group's name. When we report on the 9.95 Challenge, we combine all the 995 Challenge contributions.

Therefore, on the <u>Contributions</u> Report, the 995 Challenge amount will not match the reported total for the Challenge because some of the Challenge contributions will be listed under the home groups' names.

For Example:

Individual #1 9.95 Individual #2 9.95 Home Group A 9.95 TOTAL Challenge 29.85

Contributions Report:

995 Challenge 19.90 (Sum of Individual #1 and Individual #2)

Home Group A 9.95

- 2) Some people or groups choose to contribute more than \$9.95 and for that we are grateful. Any amount is appreciated!
- 3) Contributions made using PayPal incur a fee. Some people choose to cover that fee and so their 995 Challenge contribution is \$10.75. Out of that, Area 92 pays the 80¢ fee. We end up with \$9.95, but the fact is the person contributed \$10.75.

That may be more detailed than you cared to know. LOL However, I am a trusted servant directly responsible to those I serve, so you get the whole shebang!

PayPal: Identifying source of contributions as a member of the Fellowship – I've asked the Technology Committee if they can insert a pop-up form between the Area website and the PayPal website asking the user to confirm that they're a member of AA. The www.aa.org website uses such a form. If the user confirms, great, they go on to the contribution page. If they say no, they get an explanation of our self-support policy. This form would generate from the Area 92 website and the user could not go past it without selecting yes, no, or cancel.

When you contribute through the Area 92 website, you will see a plus sign next to "Add special instructions to the seller." Click on the plus sign (+) to put in your group name and city or group number so the correct group gets the credit for the contribution. As always, when sending contributions by mail, be sure to put your group NAME and city or group number on it. We do accept contributions from non-registered groups.

Keeping with tradition, I will choose a committee of Past-Delegates and we will discuss all of the submitted suggestions and from those suggestions, we will pick 3 to 5 topics based on the anticipated discussion within the 2-hour time restraint.

I will submit this report to the upcoming Area Newsletter and make a final report after the October Assembly and submit that report to the Area Newsletter. I will submit that report orally at the April Pre-Conference Assembly.

In AA an inventory is a process that involves taking stock of our strengths, weaknesses, values, goals and possibly our failures. Don't be afraid to critique our work. To quote

Bill W. from our publication, "Our Great Responsibility," speaking at the 8th General Service Conference, "I think that this Conference of ours be-speaks more promise and more progress for AA than any that have gone before. It holds promise and has been filled with progress because it has had trouble. And it has converted that trouble into an asset, into some growth and into a great promise." He goes on to state, "AA was born out of trouble! "In days of old, people would hold an egg up to the light of a candle to see if the egg was "Good or Bad." I think that the light we hold our ideas or actions up to is and always should be our Twelfth Step. "Will this aid our groups in carrying the message to the alcoholic who still suffers?"

WASHINGTON STATE EAST AREA 92 YOUR SEVENTH TRADITION CONTRIBUTIONS AT WORK

ACHIEVING OUR "PRIMARY PURPOSE" BEHIND THE SCENES

Every year WSEA 92 trusted servants respond to over 25,000 emails and phone calls from AA members, fellow trusted servants, Districts, suffering alcoholics, professionals, and others interested in Alcoholics Anonymous' program of recovery. The chairperson of each Special Service Committee works with their District counterparts to support, educate, and assist when called upon. Each Quarter the Area Committee, consisting of sixteen elected and appointed Area officers and twenty-five DCMS, meet at either an Assembly or Quarterly to report to the body. These (2) Assemblies and (2) Quarterly meetings are vital to keeping the body informed and updated on the finances, activities, and events of Area 92 and the General Service Office (GSD) in New York City.





1 The WSEA 92 Delegate is a voting member of the General Service Conference (GSC) representing WSEA 92, while always mindful of the good of A.A. as a whole. The Delegate shares the Conference Agenda items with the Area Committee. Many DCMs host Delegate meetings where the delegate shares the Agenda Items with GSRs so they are informed and prepared to share with their home groups. At the Pre-Conference assembly DCMs and GSRs return their District's and group's group consciences. This way the Delegate will attend the GSC

with a good sense of how the Area feels about the Agenda Items. Afterwards the Delegate travels to Area Districts sharing their experience while at the Conference and any actions taken on the Agenda Items. The Area Alternate (Alt.) Delegate assists the Delegate and assumes the duties of the Delegate if the Delegate is unable to serve their full rotation. The Alt. Delegate is the Area Registrar, overseeing that groups, DCM's and GSR's are registered with GSD, and that the Area Registrar for groups is current and accurate. They assist Districts with registering committee Chairs with GSO, and often attend Zoom meetings with fellow Alt. Delegates throughout the country.

2 The WSEA 92 Chair is the chairperson of the Area Committee and sets the agenda for and chairs all Area Assemblies and Quarterlies. Newly elected officers meet with the Chair to assist in the selection of appointed officers. Currently monthly meetings with Area Officers and Area DCMs are held and lead by the Area Chair, a tradition started by the Panel 70 chair. The Chair oversees the smooth operation of all of our Area special services with a strong focus on unity. The Area Alternate Chair assumes the



Chairperson's duties if the Chair is unable to complete the Rotation. The Alternate Chair coordinates with each District hosting an Area Assembly or Quarterly. The Chair oversees and assists where needed throughout the process, which often involves travel to preview venues and attend planning committee meetings. He/she maintains a record of each District's final report breaking down income, expenses and Attendees.



3 The WSEA 92 Secretary assists the Area Chairperson in preparing agendas, meeting notices, and distributing information to the WSEA 92 Committee. With Each new Rotation the secretary updates and distributes new Area Directories. With the help of recordings and notes taken, the secretary provides minutes of the Quarterly and Assembly conferences. The Secretary is Chair of the WSEA 92 Handbook Committee and responsible for updating the Area Handbook as motions are approved and maintaining a list

of approved and not approved motions as part the WSEA 92. Floor motions are sent to the secretary and distributed to the Area Committee in time to be considered at the Quarterly or Assembly.

4 Our WSEA 92 Archives facility houses the historical A.A. documents and memorabilia collected since the beginning of WSEA 92 in 1995 and before. Visitors enjoy viewing the old Assembly and Quarterly minutes, motions, letters, numerous photos, some with Bill, and much more. 7th tradition funds pay the rent on the facility and funds the supplies used by the Archivist to properly preserve the integrity of these precious items. At the quarterly Standing Committee Workshops, the Archives Chair update attendees on current A.A. Archives



activities and points of interest throughout the structure and is available to help District Archive Chairpersons. The Archives Chair coordinates the display of Area Archive items with the Area Archivist and arranges for volunteers to supervise the display at Area Assemblies. The Archives Chair also serves as Chairperson of the Archive Steering Committee. The Area Archivist is a separate position whose primary responsibility is the care, repair and preservation of the Area's and filing of archived items. In addition the Archivist attends the Annual Regional A.A. Archives Workshop and plans the event in the years Area 92 hosts it. The Archivist attends the National A.A. Archives Workshop once every four years.



5 wsea 92 Corrections Chair meets with District Corrections Chairs to share experiences and assist where needed. Carrying the message into local jails/prisons and providing literature for incarcerated alcoholics is usually the only help these suffering alcoholics get, and the Area Corrections Chair works diligently to see that the need is met in corrections facilities throughout WSEA 92. The

Corrections Chair also attends the National A.A. Corrections Conference once every two years.



6 The WSEA 92 Treatment and Accessibility Chair not only focuses on alcoholics in treatment, but also helps Districts find solutions for those alcoholics with accessibility issues due to disability, remote location, illness, or any reason that prevents them being able to attend in-person or online meetings. Taking meetings into local treatment facilities and providing facilities with A.A. literature is a priority and among the topics discussed when the Area Treatment and District Treatment Chairs meet and share their experiences, struggles, and solutions.

The Area Treatment and Corrections Bridge the Gap Chairs work with Districts to help coordinate with Correction, and Treatment Facilities to connect recovering alcoholics being released with a member of Alcoholics Anonymous from the district in which they reside who will take them to meetings and introduce them to others, so they feel welcomed and comfortable as they continue their path of recovery.





Public Information (P.I.) Chair coordinates the broadcasting of our audio and video Public Service Announcements (PSAs) with local radio and television stations. The Area P.I. Chair works with Districts to help facilitate this most important work to reach the suffering alcoholic who may not know about A.A. or may not know how to find us.

Professionals are frequently the first contact for an Alcoholic. Our Area Cooperation With the Professional Community (CPC) Chair meets with District CPC chairs to network with one another, share new information from GSO, brainstorm solutions to problems, and encourages and inspires confidence as they reach out to Medical, Legal, Hospital, Court and other professionals who may have interactions with the suffering alcoholic.



🛢 A large variety of A.A. literature and pamphlets are available for sale at every WSEA 92 Assembly and Quarterly thanks to the dedication of our WSEA 92 Literature/GV (Grapevine/LaViña) Chair. The Literature Chair is also available to assist Districts with their literature needs and often travels to other A.A. events in our Area to make Area 92 Literature available. This Chairperson literally does the heavy lifting and moving as the books and pamphlets displays are set up and taken down and loaded twice for every event.

10 The WSEA 92 Newsletter Editor has the joy of collecting monthly reports from all 16 Area elected and appointed officers and 25 DCMs. Once collected the reports are edited if necessary, and the layout/design is prepared with any flyers of upcoming events or other important information added, and the editor produces the final product. The Editor then sends it electronically to the Area Committee, Alternate DCMs, Past Delegates and other members requesting a copy. For trusted servants and Past Delegates without electronic means, hard copies are printed and mailed. The Area Newsletter Editor is always looking for news stories inside and outside of our own Area.



11 The Translation Chair Insures there is an interpreter at all Area Assemblies, Quarterlies, Standing Committee Workshops and all other events the Area hosts. Translation equipment is provided to all Spanish speaking members and the Translation Chair is responsible for the maintenance and repair of the equipment to insure it is always in good working order. In addition the Translation chair assists Area Officers with document translation. The Area Translation Chairs assists districts if they need help finding a translator for an event, they are hosting.



12 Your WSEA 92 Treasurer & Alternate (Alt.) Treasurer are responsible for the prudent stewardship and accounting of YDUR 7th Tradition Contributions. The Area Alt. Treasurer deposits contributions to the bank, and credits each individual, group, and district contributing. The Alt Treasurer transfers PayPal contributions to the bank, crediting back each contributor the PayPal fee and charging the

fee to WSEA 92. The Alt. Treasurer is the chair of the Area Finance Committee which meets monthly. The Area Treasurer creates the annual budget based on historical and known data, pays all Area Expenses, reimburses trusted servants' business-related expenses and mileage, reconciles bank statements with QuickBooks, and registers the Area Committee for events and procures all hotel accommodations. Monthly reports to the Finance Committee are made by both positions and each Quarter the Treasurer and Alternate Treasurer report on the state of the Area's finances to the body at WSEA 92 Assemblies and Quarterlies.

WSEA 92 Elected Officers and Special Service Chairpersons are worthy trusted servants, devoted to service in Alcoholics Anonymous to realize our "Primary Purpose" of reaching the still suffering alcoholic. Without your 7th Tradition contributions the vital work of these trusted servants would not be possible. For that we humbly thank you and urge your continued generous support so others in our Area might be blessed with the gift of sobriety as we have been.

May the God of your understanding Bless you.
