#### Did you know?

On October 3rd, 1945-AA Grapevine was adopted as a national publication of AA!

The Grapevine was created by six AA members in the New York area... 4 women and 2 men.

With the blessings of AA's co-founder Bill W., they published the first issue in June of 1944, just 9 years after the founding of AA. A copy of that first issue was sent to every AA group - about 300 at the time... and to all known AA members in the armed services overseas. An entire page with the heading, "Mail Call for All AA's in the Armed Forces," was devoted to letters from these members, who began calling the Grapevine their "meeting in print." The title stuck, and today the Grapevine and La Vina carry it on their covers.

At the heart of early Grapevines, then as now, were first-person stories. There were also news and notes on current happenings at the Central Office, plus reports of the explosion of new groups in North America and around the world. In addition to AA news, there were book reviews and magazine reprints and pieces written by non AA's, including some well-known literary figures. Discussed were such burning topics of the day as the place of women in AA, returning veterans, and cross-addiction.

The history of the Grapevine is the history of the growth of Alcoholics Anonymous.

On a related note, District 20 has reassimilated/merged (use your own word) back from whence it came some 10 to 20 years ago (I don't have the exact date) into District 6 once again. Alt Treasurer's Report for Area 92 Newsletter October 2024

Greetings, Area 92.

It's been exciting to see the 9.95 Challenge contributions coming in. We received 24 contributions in the month of September alone! The total 9.95 Challenge income at the end of September is \$1,050.37!

I want to remind folks that the idea of this challenge is for *individuals* to contribute \$9.95. When a group of, say, 10 people contributes \$9.95, it's as if only one person contributed. While we are grateful for all contributions, we want to be clear that the idea behind \$9.95 was per person, rather than per group.

The Finance Committee has come to an agreement on the final form of the motion we will present at the January Quarterly. We are proposing that the Finance Committee be authorized to handle requests for additional seed money, rather than asking the whole body to address the request. It's not an "expense"; it's a loan. An expenditure would rightly go back to the home groups for a decision.

The Finance Committee is committed to safeguarding the Area finances and would not wantonly authorize an exorbitant loan. The Finance Committee focuses on conserving Area funds.

Speaking of which, the Finance Committee will be discussing ways to proactively conserve Area funds. Specifically, where can we cut costs? Which services do we cut? That sort of thing. Contact me at <a href="mailto:alt-treasurer@area92aa.org">alt-treasurer@area92aa.org</a> to get the invitation to the Finance Committee meeting.

Lastly, I want to point out that several years ago the Area approved a line of credit for the Literature Committee. That money was given to the Literature Chair to purchase literature. Since then, the money has been handled entirely by the Literature Chair. The Area is asking for an annual report because it is not personal money. It is Area money.

That being said, we already have in place a system of sorts for handling funds outside of the Area 92 General Fund. So, when we talk about the Pink Can motion, please keep in mind that we already do something very like it and it seems to be working quite well (except that we need better reporting). In fact, the Corrections Committee is not asking for any money from the Area. The money would all come from AA members and groups who want to contribute to Corrections work but don't have a district Corrections connection.

**1.** PayPal: Identifying source of contributions as a member of the Fellowship – I've asked the Technology Committee if they can insert a pop-up form between the Area website and the PayPal website asking the user to confirm that they're a member of AA. The www.aa.org website uses such a form. If the user confirms, great, they go on to the contribution page. If they say no, they get an explanation of our self-support policy. This form would generate from the Area 92 website and the user could not go past it without selecting yes, no, or cancel.

When you contribute through the Area 92 website, you will see a plus sign next to "Add special instructions to the seller." Click on the plus sign (+) to put in your group name and city or group number so the correct group gets the credit for the contribution. As always, when sending contributions by mail, be sure to put your group NAME and city or group number on it. We do accept contributions from non-registered groups.

#### **Area Secretary**

I have been busy getting together the paperwork for the upcoming October Assembly on October 25-27, 20245 in Coeur d'Alene. I will be forwarding this information to Area when we get closer to the Assembly. I have attached the draft copy of the April pre-conference minutes; they are not final and are missing financial information that reconciles. The Feb through present financials have been revised and corrected to give us accurate numbers that reconcile, however January 2024 has not been completed. I have asked for January 2024 revised figures but have not received them yet to complete that part of the minutes.

The Handbook Committee met virtually on Sept 19, 2024. Present where Catherine B., Paula T. and Virginia R. We discussed concerns about the "Google" translation problem of the handbook and other documents. Virginia has been using 'DeepL', a translation app that appears to be much better at translating. The free option (1 pg at a time) is limited therefore we will be looking into cost to purchase a wider usage plan that can be used by the Area for all translated documents. Hopefully we will have more information at the assembly.

The other topic of concern was the motion process and updating the handbook. This was good timing as we will be discussing this at our upcoming WSEA Area Inventory.

Question #4. Why does Area not have a motion process?

Specifically, we looked at the upcoming motion that had come out of the finance committee. We agree that it was not concise and could not support it as written. The motion should be sufficient to go into the handbook as written without having to add another motion to "update handbook language", with added language to "clarify" what the motions intent/duty/action is. The committee submitted a suggestion, a rewritten motion back to the finance committee. It is unknown what the status of that motion is at this time. What became clear was there is not a good understanding of how a motion should be written to convey an action and update the handbook at the same time.

The committee agreed that there should be a process of having the Handbook Committee assist the makers of a motion in the writing process before submitting a motion to the body. The committee believes having input in this process would help to present a clearer more concise motion therefore would be beneficial to the Area.

Further discussion on this topic to be had.

Archives Workshop in beautiful Des Moines, IA. This is the 2nd National Workshop that I've attended and the theme was 24 Hours a Day: Then & Now. We will continue to have small sessions but if you are interested in participating before January, please let me know. You are most welcome and needed.

Hello Area 92!!

October has arrived, and along with it came FALL!! Although I already am grieving the loss of what seemed to be a short summer run, I welcome the beautiful change of colors and brisk air. Great season for windows down, top back road trips in the Jeep. Thank you, AA, for showing me acceptance and joy in change.

So, what things occurred in the world of Corrections as we brisked through September...

- Bridging The Gap Workshop Weekend (BTGWW): Both our Delegate, Lisa G., and I attended this event held in Missoula on Sep 6

th

-8

th. This workshop travels around the country from one

hosting Area to another and this was their 33rd year! Neither Lisa nor I had ever heard of it so this was a must for us to check out, since it was basically in our backyard. The events name reflects that it was founded back when both Corrections and Treatment were still under the single service committee of H&I. Even so, there was evident in its topics and conversations that Treatments; Bridging the Gap, and Corrections; Bridge/Pre-Release/Reentry programs are different, not only in their operations but in their nature as well.

Some highlights of the weekend we enjoyed were, knowledge of a national database of Volunteers and POC's that the workshop had built over the last three decades. Tips and experiences on building committees. Training Volunteers. Kelly C. from GSO's Treatment Desk Staff shared how GSO and its Committees work, she also was our guest speaker for Saturday evening. What a treat she was! We learned about Gap Bridging activity from hospitals, and that there is a long-standing program back east called "The Man on The Bed".

What I thought was going to be a dry wrap up Sunday morning turned out to be very informative; AI technology applied to what we do in our Committees. Shared was some very useful tools and templates for evolvement of simple excel spreadsheets used to manage Volunteer lists and such to having AI automatically reach out at given intervals via email to see if the Volunteer is still active and willing. And other deep techy possible applications of AI to make our work more effective and illuminate those pesky cracks which those transitioning to AA communities frequently fall into. We also got to see both southern California, and Ontario Canada makes bids for 2025 and 2026 BTGW. This is something that your Delegate and I would love to see Area 92 step up. This was really a great workshop with a hundred in attendance representing Areas from across the US and Canada.

One more highlight from this event, during introductions a volunteer I had never met whom I reached out to for a Bridge out of AHCC last spring, stood up from the second row during introductions and stated he was from Area 92 District 17!! Lisa and I were way in the back and both our jaws dropped open. Dave and I had never met until that weekend, but I came away with a new friend and a new Service Sponsee! The theme was "Literature" and I came all prepared to share on our F-26 & F-73 Corrections Correspondence Program and the F-162 & F-163 Bridge forms, but the eight folks who attended the Corrections room, one of whom was a past Delegate, took a group conscious in favor of going over the "Motion to Establish a Dedicated Account for the Area 92 Corrections Pink Can Program" motion which is coming up at the Area October Assembly. I was introduced to Dale B Area 92 Corrections Chair. Dale had told me about an individual that was going to be released in the near future from Airway Heights Correctional Facility. Dale explained to me that the inside Member had submitted a Prerelease Request (F-163 form) requesting an A.A. Contact to take him to an A.A. meeting upon his release. Dale also shared the Sucurus eMessaging App so I could make contact with him while he was still in the States custody and to introduce myself approximately 1 month before his release date. We maintained contact until he was released on June 5th .

Late afternoon June 5th we scheduled an early morning meeting the next day. I picked him up at his transition house and we went to the "Our Club" A.A meeting in downtown Spokane per his request, as he had been there before and was familiar with that group.

He made arrangements with some acquaintances at the meeting that were able to drive him around and take care of his after-release business, as I had informed him that as a Temporary Contact, it was not in my service work to perform those functions.

I am excited that I was able to perform this very important service work and look forward to working with many more individuals that are interested in taking advantage of this BTG and/or bridging program." Sincerely,



My name is Mark and I'm an Alcoholic. My sobriety date is 10/26/1985. My service position is Oregon Area 58, Panel 48 Past-Delegate.

While attending the Pacific Northwest Conference a few of us past delegates were discussing the upcoming Area 92 Inventory. The discussion centered around whether we should use an outside facilitator as the Home Group and the District Inventory suggest. We usually use an Area 92 Past-Delegate. It was pointed out that I'm an Oregon Area 58 Past-Delegate who has lived and attended Area 92 Assemblies for the past 19 years and I could be both. While this may be a little lame, I was chosen to facilitate the 2024 inventory.

From our Area 92 Handbook: Section 3.0, item h, WSEA 92 will allow two hours for an Area Inventory at non-election October Assemblies. The inventory will be chaired by a Past-Delegate who will be funded by the Area. The inventory will contain three to five questions coming from any or all of the following: Home Groups, GSR Round table meetings, DCM Round table meetings, or from the Area Committee. A follow-up report will be given at the following April Pre-Conference Assembly.

Keeping with tradition, I will choose a committee of Past-Delegates and we will discuss all of the submitted suggestions and from those suggestions, we will pick 3 to 5 topics based on the anticipated discussion within the 2-hour time restraint. # Keys to Corrections



### A Column to Inform and Encourage

Welcome to our fourth installment of what we hope to be a long running column of informative, encouraging, and inspirational topics from the wonderful world of service in AA Corrections. We welcome you to the... **Keys to Corrections!** 

This month we are going to take a look at long standing, yet controversial program called; "The Pink Can". This fund-raising initiative as stated in the 2006 fall edition of GSO's Box 459, was started back in 1957. Here is a little of what this Box 459 article "Pink Cans: Small Change Brings Big Results" shares.

"The Northern California Area Hospitals and Institutions committee (H&I) was rapidly expanding its work in prisons, and the need for literature was increasing by leaps and bounds, to the point where it could no longer be met by individual contributions. Someone came up with the idea of passing around a can at group meetings, explaining that the pennies, nickels, dimes, and quarters dropped into the can were intended for alcoholics in prisons and hospitals. How to make the cans stand out? Paint them pink!"

So, great idea, right?! What could make this so controversial? The article goes on to say...

"In the beginning, some members were afraid that donations to the pink cans would decrease group contributions, and mindful of that possibility, the committee has always emphasized the importance of providing clear information. They send each group a flyer explaining what the cans are for, print information in local A.A. newsletters, and always suggest that the secretary emphasize the importance of contributions to group expenses first."

Recently a flyer, believed to be from the 90's, was found in the Pioneer Group meetings literature materials in Walla Walla's Washington State Penitentiary. Founded in 1942 this is the oldest continuous running corrections meeting behind bars in the world. The flyer is titled; "Washington Area East 12<sup>th</sup> Step Literature: What are those PINK CANS for?" Within this full-page narrative flyer, reads the following paragraph.

"One of the fears expressed of the PINK CAN was that they would subtract from the support of the meetings. This was dispelled by groups that determined their meeting donations were the same with or without the PINK CAN."

Have fears been "dispelled"? I suppose that could be subjectable, but let's consider some apparent evidence of acceptance by our bodies of Trusted Servants. One, the previously quoted 2006 Box 459 article. Box 459 is GSO's newsletter to our Fellowship. Two, AAWS's Corrections Workbook (M-45I) has no less than three full pages giving several examples of Pink Can or pink can type programs used by Groups, Districts, and Areas across the country. Of all these, only one makes mention of a "budgeted" literature allocation type structure. This is what it says in our Corrections Workbook.

"In Kansas, it is reported that they have a yearly sum of approximately \$1000 that is allocated for literature. Although this is the biggest item in their budget, it is still a meager sum, and a short while ago they started placing contribution cans at their meetings. As they tell all their members, even the smallest contribution helps."

Fears dispelled or not, it certainly seems that after more than sixty years in existence, the effectiveness of the Pink Can has proved itself, and it's recorded history in our archives and submission into our Fellowship

approved publications, would certainly reflect at least an embrace if not a full nod of approval. One thing for certain, AA literature behind the walls is one of the highest calls to duty for our basic lifesaving materials. The Workbooks funding suggestions section, "Shared Experience on How Committees Collect Contributions for Literature" states.

"Alcoholics confined in correctional facilities usually have just one A.A. meeting a week available to them, if they are lucky. A sizable number are on wait a list and go to none at all. But there's another way to carry the message to these people: Provide them with meetings in print through and additional AAWS literature, pamphlets and the Grapevine. The only stumbling block is money."

"How are local corrections committees funded? How do they accumulate literature for inside meetings? These questions have become a frequent refrain at all levels of service, including the General Service Office, where more that 90 percent of the letters that cross the Corrections Desk contain requests for free literature. In the spirit of AA's Seventh Tradition, the search is on for financing approaches that make practical as well as spiritual sense."
