**International Convention:** AA's 90th Anniversary July 3rd -6th in Vancouver BC. There will be the Thursday night party, flag ceremony, stadium meetings and the Saturday night old timers meeting. There will also be over 20 plus hospitality suites. The Pacific Region Hospitality room will be located at the Fairmont Hotel. There will be over 250 different meetings to pick from! Room blocks are constantly being updated and there is still time to register.

**Plain Language Big Book** is also back in stock, this is the 2nd printing of the first addition. After the first 70,000 copies sold out quickly. The new **Service Manual** has also been released and is in stock.

**AAWS Discount Literature Packages:** List price increases effective January 22, 2025. These adjustments are being made in response to costs of materials, manufacturing paper, printing,

binding and delivery. These adjusted prices have been calculated to reflect a consistent 35% discount off the combined total list prices of the contents of the packages. You can find the full list on the meeting guide app, under news.

**Grapevine News:** Grapevine and La Vina Apps are now available Internationally! The La Vina print subscription has been raised to \$18.00 as of Jan 1st 2025 and there will also be a \$1.00 price increase to all Grapevine and La Vina Books beginning Feb 1st, 2025. **YPAA World Tour: Kickoff at the 64th ICYPAA**, in Austin Texas, Audio Stories from young people in AA are now available, there are 10 stories to listen to.

**American Sign Language** videos are now available on the Grapevine & La Vina Youtube Channel

Q3 Financial Report was distributed and is available online.

AAWS- For the 9 months that ended Sept 30, 2024 we had a total operating revenue of \$14,591,894, which is 3% more than YTD budget. We have spent \$13,417,466 in operating funds which is 3% less than budget. The reserve fund is 6.41 months, with a reserve fund balance of \$11.81 M. Total 7th Tradition Contributions is \$8.1 M, gross literature is \$10.8M and net is \$5.9 M.



## Old Business

- **Standing Committee Workshop** : Reported that the Dec SCW "Service Fair" was a big hit and wonderful success. Super well attended, and Spokane Districts 2,13, and 17 Corrections Chairs did a fantastic job teaming the Corrections Booth. Paper coins were made, CCS info shared, Bridge & Bridging the Gap info shared, and new Volunteers signed up, Luis from District 25 stepped up as our Corrections Committee Latino Community Chair. Good food, lots of engagement, and all the standing committee's had outstanding booths. The room activity was just a-buzz!
- **Literature / Tablets** : Dist 4's Mike T. shared that at Coyote Ridge they do have access to the PLBB on their tablets. However, they are not allowed to bring the tablets to their AA meetings. This is also true at Walla Walla's Washington State Penitentiary. No new literature orders were placed this past month. Awaiting Pink Can Account activation and funds availability before soliciting for orders.

- **Editorial Special: Please Step Up** : District 4's Mike T. again provided me with a great letter by a CRCC released inmate which we submitted for the Jan 2025 *Editorial Special*. In the introduction of the Editorial Special I had included the following line: "Kevin, if you happen to read this, I suspect it will transport you back to this moment with pen in hand." A few days after the newsletter was published, I received an email from this unknown to me "Kevin" who shared how touched he was to read this. He had forgotten his writing that letter so many years ago, and even now, while enjoying his freedom today, it did in fact transport him back to that moment on the inside. He shared how this stirred gratitude within him. Guess what,,, people are reading and following what we are doing!
- **The "Keys to Corrections" Column** : I had no *Keys to Corrections* article for January, but did include a write up with pictures, a live on scene report from the District 2 hosted Dec SCW Service Fair.
- **Pink Can Account "Proposal / Motion"** : We have a Pink Can Account established!! The Area Treasure opened an account at Numerica with an initial \$25 deposit. I as Area Corrections Chair went down that same week and got signed onto the account and secured a debit card for the account. So, although it does not look like we will have the electronic contribution logistics in place on the website in time for the Jan 17<sup>th</sup>-18<sup>th</sup> Area Quarterly, I will be able to announce that we have the account. This is very exciting.
- **GSC Preliminary Agenda Items**: The Area will be having a zoom workshop meeting later in the week, for all of the Panel 74 Chairs, and DCM's. It will cover how we will be using Google's "shared document" platform to work the Agenda Synopsis sheets. There will be more to come on this as we progress through the next several weeks. 




