The following is what I presented for the Young People's Panel at the Pacific Region Alcoholic Anonymous Service Assembly (PRAASA) in Anchorage

Hi I am Dan and I am an alcoholic.

I have the honor of serving as the Alt-Delegate for Washington East Area 92.

My homegroup is Northern Lights in Spokane, Washington We meet Monday evenings 7:30pm

My sobriety date is January 10th, 1979

One of the unique things about AA meetings is that people can share their most devastating experiences, and often, there's laughter. Why? I think it's because honest sharing, whether it marks the beginning of recovery or shows someone already working the steps, is a testament to the hope that AA offers for this seemingly hopeless disease of alcoholism.

I first encountered AA at 21, through a treatment center. I learned about alcoholism, was encouraged to self-reflect, and was introduced to the Twelve Steps. I worked through Steps 1-9 as best I could while in treatment and attended my first AA meeting as a patient, where I felt welcomed. Socially awkward and needing to learn so much about life, I needed to explore new things, and it was crucial to do this with others committed to sobriety. I was lucky to find many people my age in AA. I had no idea what I enjoyed without alcohol, as it had always been a part of my activities. I was still terrified of external forces triggering a relapse. I lacked faith that connecting with my higher power through the steps would work in all aspects of my life. But, as I continued to stay sober, through both perceived wins and losses, my faith in AA grew, and my fear diminished. This has allowed me to enjoy life more fully—a wonderful bonus, considering all I initially wanted was to stop drinking. Before AA, my pursuit of entertainment and pleasure was just a way to mask my fears. This was different. What a gift! Continuing to nurture my relationship with my higher power through 12th-step work, attending meetings, and participating in service brings joy and purpose to my life. My first sponsor told me the best way to help others stay sober was to stay sober myself. This gave me a reason to live when I desperately needed one. This primary purpose has remained unchanged throughout my 46 years of sobriety.

How can you actually enjoy an AA business meeting, service committee meeting, or Area assembly?

First, I believe no one should join a committee until after working on their Ninth Step. My ego still exists, and I can forget that God speaks through group conscience. I can become resentful when my way (which, naturally, I believe is the right way) isn't followed, or when it takes too long for others to see my point of

view. I try to remember that if I'm angry, I'm wrong, even if I'm factually correct. That means I have an internal issue that only working the steps can resolve. If the anger stems from fear that AA might be harmed by something, I hope I haven't acted in a way that creates disunity. Unity is paramount.

Second, I need to understand the business at hand and how I can contribute to its progress. I love being involved with groups that get things done.

Third, I try to make others feel valued in their service, just as others did for me.

Fourth, I enjoy the fellowship of people working toward our primary purpose: helping the still-suffering alcoholic.

You are the best people to be around, and thank you for your service!

In a couple days I am off with several others to PRAASA in Anchorage for a weekend of service, mingling, and updates on things elsewhere in AA.

AA at Eastern State Hospital: I have recently been contacted by an Eastern State representative who is enthusiastic and seeking AA meetings at their facility in Medical Lake. Eastern State is an involuntary mental health facility for those unaware. This is something new and exciting to A92 and we will be looking for volunteers to support these meetings. The details are yet to be worked out. I have spoken with their staff representative and reached out to our own people in A92. This is not quite corrections or CPC and there is an element of PI as well, so I have reached out to various acquaintances elsewhere as well as corrections and PI at GSO (on the advice of my friend trustee Carolyn W). So far I have gotten some good feedback with which to proceed.

I am aware of, and have made contact with, a couple people elsewhere (A72 and NorCal H&I) who do have some years of experience taking AA into involuntary facilities like Eastern State. This is promising and I will be meeting with at least a couple people at PRAASA this weekend in Anchorage to discuss some of the details and aspects of this type of service. This is an exciting opportunity and I want to do the best we can out of the gate for this population of suffering alcoholics.

Anyone interested in becoming a part of this effort please contact me and we can start accumulating a volunteer list. I imagine living within the vicinity of Medical lake would be desirable but not required if you're willing to travel. The details such as facility clearance and any required training etc. will be forthcoming. I will be contacting their representative and a handful of our people for some kind of meeting, perhaps virtual, to discuss how to proceed. No doubt it will be a learning process.

Alt-Treasurer: In other news and as a reminder we are accepting resumes for the Alt-Treasurer position that our Rainey has vacated due to health considerations. Please email your resume to me at: chair@area92aa.org and be prepared to present at the mic (or virtually) when we meet in Libby this April. Thanks to all for considering this vital position. If you're not considering it and you're

capable please do. This is a very critical part of our service structure.

We currently have three motions for consideration at the pre-conference in Libby, two out of the finance committee and one more from the tech committee. I believe Jennifer has already made the finance committee ones available via email and on the drive and the tech committee one should be forthcoming.

This will be a very busy assembly as we have Conference agenda items to cover as well as a report on our recent Area inventory in addition to the other business. Please come prepared to get busy. I recently met an AA historian, Gary from Atlanta GA, at the Blending of Time Conference in Tacoma. He introduced me to another person who will be forwarding me useful material about Washington State Penitentiary for the National Corrections Conference hospitality suite archives this July at the International Convention in British Columbia Canada. Who says service isn't fun? I always hated history when I was in school, but they made me study it.

I love it now that it's my own choice.

Off to Anchorage and PRAASA tomorrow am along with a pretty significant crew from A92. Speaking of having fun in AA.

Hi Area 92,

District 4 has been working on reorganizing our general services structure. For many years our district general service structure has been two separate organizations. a Central Office and a District Committee. The Central Office has been responsible for the book store, the answering service, Information Services (website, meeting schedules), special events (4th of July picnic, gratitude banquet, new years eve party), and the service committees (corrections, archives, treatment and accessibility, and CPC/PI). The District Committee has been responsible for the General Service Representatives (GSR) schools, GSR monthly meetings, area 92 quarterlies and assemblies, general service office information distribution, general service conference (GSC) information, delegate report-backs, GSC agenda review process.

The District 4 service structure has been described as Central Office--local services and District Committee--AA world services. The groups exercised their responsibility and authority of the Central Office and District Committee through Central Office Reps and GSRs, respectively.

Most recently the monthly meetings were the 2nd Saturday of the month--District Committee Chaired by the District Committee Member (DCM) with GSRs at 10am followed by the Central Office chaired by CO Chair with Committee Chairs at 11. Both Organizations had chairs, secretaries, and treasures. The groups provided support for the services by contributing funds to the Central Office and to the District Committee. During the last rotation (2023) of trusted servants the Central Office created an ad-hoc committee to look into consolidation of the two service structures.

The ad-hoc committee presented a motion to the Central Office that: **District 4 General Services** Structure align with Area 92 General Services and dissolve the Central Office. The motion listed the benefits to adopting this proposal which included: a single unified service structure, the GSRs will be the focal point of contact for the home groups, the GSRs participation in the new structure will gain a better understanding of Area 92 quarterlies and assemblies, the service structure will align better with the General Service Manual and the AA Group Pamphlet, easier to explain to new service workers in District 4, one service meeting for all the GSRs and Service Committee Chairs, reduction in redundant service positions i.e. one chair, one secretary, and one treasurer. Charts were added to the motion showing the current structure of two organizations and the separation and also a chart was added of the current Area 92 structure and the proposed District 4 organization. One of the discussion points that came up regularly in the discussion of the motion was that the Tri-cities AA is made up of only one district and that mainly Central Offices were needed when multiple districts needed the Central Office services to help the districts organize their efforts in reaching the still suffering alcoholic, and that the Tri-cities being one district did not need this extra organization. After a couple months of posting the motion and discussion the groups through the Central Office reps passed the motion in February's business meeting. We hope this unification of services provides the groups a better line of communication of all the service activities that are happening in the Tri-cities and throughout our Area 92 and in all of Alcoholics Anonymous in the US and Canada and the rest of the world.





Keys to Corrections



A Column to Inform and Encourage

Welcome to our fifth installment of what we hope to be a long running column of informative, encouraging, and inspirational topics from the wonderful world of service in AA Corrections. We welcome you to the... **Keys to Corrections!**

This month we are going to look at how we as an AA Area and its Districts support its regions Prisons. The first thing that should be known is that A.A.W.S Corrections Workbook addresses the inherent differences between how we as the Hand of AA reach into a Prison vs a Jail or Juvenile facility.

"Although the basics of carrying AA's message into youth detention centers and short-term facilities are no different than carrying the message into any other Correctional Facility, many Area Corrections Committees felt there was an expressed need to include some information in this workbook regarding what they viewed as added challenges to service work in these two areas and, based on their experiences, some suggestions on leading meetings in these institutions.

Experience shows that there is often a rapid turnover of individuals in both youth detention centers and short-term facilities. Frequently, attendance at AA meetings in these institutions may not be voluntary. It is prudent to be aware that, like many AA members in the beginning, some people may not believe they have a problem with alcohol and resent attending an AA meeting. It is important to remember that AA is there to offer a message of hope. You may not be able to see immediate results, but a seed may be planted."

So, what does this mean, and why highlight it? Stemming from the single factor of length of stay, or as the Workbook termed it "rapid turnover of individuals." Historically we have experienced a much greater willingness with our Prisons wanting us to have meetings behind their walls, than our Jails or Juvenile facilities. Not that we do not have some where meetings are taken in, but the numbers speak for themselves. 100% of our Area 92 Prisons have meetings, whereas only a fraction of our Jails and Juvenile centers welcomes us in with meetings. Their residents simply are not there long enough. So, we support in different ways, often heavily relying on our message of Hope being carried by our literature.

Our level of involvement and activities in our Prisons though are starkly different. They well could be held up as pinnacle examples of AA's effectiveness at carrying its Message in the corrections arena. Here in Area 92, this has been the case for decades, long before we were even Area 92. In fact, we have the unique and distinct claim to having our Walla Walla Pioneer Group be the second registered AA group meeting ever behind the walls, founded only weeks after San Quinten. And it is also the longest continuous running correctional facility group in the world.

So, what goes on with AA in our Area 92 Prisons? We have five Prisons: Airway Heights next door to Spokane WA, Coyote Ridge in Connell WA, ICIO in Orofino ID, NICI in Cottonwood ID, and WSP in Walla Walla WA. All five of our Prisons have impressive levels of involvement, so we shall fairly take them one at a time, in alphabetical order. You can view information on all our Prisons, Jails, and Juvenile facilities at our Corrections webpage's "interactive map" here; Corrections – Area 92 Alcoholics Anonymous https://area92aa.org/area-committee/standing-committees/corrections/

This edition we will look at what goes on in our Airway Heights Corrections Center (AHCC)

Spokane is comprised of four Districts; 2, 3, 13, and 17. These Districts work collaboratively but only District 3 actually has any correctional facilities. So, Airway Heights Corrections Center resides in District 3 who is currently very active with its support. One important thing to be aware of when it comes to meetings in facilities, there is an extremely important relationship that must be established and maintained between the correctional professional who oversees community involvement (Community Partnership Program




