Area Chairperson

The General Service Conference is wrapping up in New York. I look forward to hearing the highlights from this year when Lisa and Dan return, and what may be actionable.

I was troubled by a recent social media post from a fairly high profile individual (an acquaintance of mine and a very visible AA member) because it expressed a strong personal opinion about controversial political content.

A personal note: I also have a social media presence (including one that is professionally monitored) and I try to be deliberate to not express anything controversial. While it's tempting to engage in public discourse I honestly feel as an elected servant I don't have that luxury if I am to be "compliant" with our traditions.

An observation about social media and AA. We are all charged with being very careful what we post on social media, particularly that it be compliant with our Tradition 10: "No AA group or member should ever, in such a way as to implicate AA, express any opinion on outside controversial issues - particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever."

These directions are specific. Today our world social and political climate can be turbulent as well as caustic. I submit that for the sake of our beloved AA we are wise to avoid any such public engagements no matter the temptation or provocation. It's not always easy but it's a practice I have managed to cultivate over time.

For nearly 90 years now we have managed as a Society to largely avoid the dangerous pitfalls that our failed predecessors succumbed to. No doubt there is a human tendency for us old-timers to get comfortable and complacent about the strength of our sobriety and thus relax a strict compliance with tradition. This might be no big deal to old-timers (personally) but what about those we are mentoring, and our new-comers? People are watching.

A personal torch I have chosen to carry is for our young people, or YPAAs. As AAs future they should be courted and included in everything we do. Let them see us argue and disagree and let's include them in AA business because they are likely to have valuable perspectives not available to us old timers.

But let's keep our discussions confined to the business of AA. "Shoemaker stick to thy last" or something like that. Moving on....

Recently I and my sponsee Ricky had fun at Airway Heights as speakers and were joined by our own Delegate Lisa who has been "making the rounds" and burning up the pavement between our prisons here in Area 92 lately including later this month (I think) a visit to speak at Coyote Ridge Correctional Institution later this month, I presume to give a delegate report. How cool is that?

Rest assured I will mention (brag about) this November in Nashville Tennessee when we bid to bring the National Corrections Conference here in November 2027. Thank you Lisa for acknowledging the value of volunteering in hospitals and institutions (what we call corrections and treatment here in A92).

In related happy news we have been given a green light to start meetings at Eastern State Hospital. I have learned a lot since my first contact with staff member Reverend Ana. It turns out there were in person meetings up until the pandemic and we have brought some of those volunteers back into the loop on this. We are seeking more and I have assembled a temporary but capable committee (until we actually start meetings and this committee becomes autonomous) to bring this effort to fruition. There is a walkthrough of the facility schedule in early June to meet with the staff and work out the details.

Any who are interested or may know someone we are seeking volunteers (I expect mostly from the Spokane area as the facility is in Medical Lake) to go to the inside meetings. Please contact me and I'll put you in contact with the committee.

Incidentally an original purpose of the National Corrections Conference is to foster volunteerism and one big reason I am so invested in bringing the event to Eastern Washington and Washington State Penitentiary. I will surely help us to get more of our people involved. I am busy and a bit overwhelmed at the quantity of archival prison material I am charged with assembling at the NCC Hospitality Suite this July at the International in Vancouver BC Canada. Still I will slog on to the best of my ability and try to do my best. I have much knowledge and experience but am not by nature a detail person and don't really have any archives experience albeit I have had much cooperation and help from those I have approached. Hoping this effort comes off well.

As I am writing this a memorial is going on for my dear sister in sobriety, Rainey. I intended to be there, but at the very last minute my sister, who was in the hospital with pneumonia, complicated by COPD, called me to say she was being released from the hospital and there was no one who could take her home. Of course I would be there for her, and be there for Rainey in spirit. Rainey was intelligent and sharp, wise, loving and a real inspiration to those whose lives she touched. And she knew Robert's Rules of Order better than almost anyone at our meetings. I will miss her dearly.

April was an especially busy month. We elected Anna V to be our Alternate Treasurer at the Assembly and since then Anna and I have spent several Zoom sessions bringing her up to speed on our Area Quickbooks and Paypal procedures, as well as the other Alt Treasurer's responsibilities. Anna has good past and current QuickBooks experience so very little training is needed. I am excited to team up with Anna for the remainder of my rotation.

The Area Income Taxes are filed, the Area Mailbox subscription is renewed and mail forwarding is updated with Anna as the recipient. The books are balanced and reports are prepared for distribution to the Finance Committee.

The total expenses for April were \$13,750. (rounded) and Income was \$5,500. April ended with

a net loss -\$8250.00. The budget for April was \$12,200 which means we were about \$1,550. over budget. However, It is important to note that reimbursement checks were issued for expenses from March, such as the Delegate's expenses to attend Praasa, and other mileage reimbursements for the March standing committee workshop. We are blessed to have so many a great number of individuals in our Area that are full of Service and knowledge. Rainey was mine. A Service Sponsor is a subtle asset that gives one a sense of security as one ventures into uncomfortable new territories of Service. They give us strength to say "yes" to that scary next step when we may otherwise say "no". We know in the backs of our mind, "I can always ask my Service Sponsor, and they will help me through." She was my greatest cheerleader when I was District 2's Corrections Chair, and she fueled me.

As the end of that rotation approached, I was torn between making myself available for District 2 DCM or the Area Corrections Chair. Keys to Corrections



A Column to Inform and Encourage

Welcome to our sixth installment of what we hope to be a long running column of informative, encouraging, and inspirational topics from the wonderful world of service in AA Corrections. We welcome you to the... **Keys to Corrections!**

This month we are continuing to look at how we as an AA Area and its Districts support its regions Prisons. The first thing that should be known is that A.A.W.S Corrections Workbook addresses the inherent differences between how we as the Hand of AA reach into a Prison vs a Jail or Juvenile facility.

"Although the basics of carrying AA's message into youth detention centers and short-term facilities are no different than carrying the message into any other Correctional Facility, many Area Corrections Committees felt there was an expressed need to include some information in this workbook regarding what they viewed as added challenges to service work in these two areas and, based on their experiences, some suggestions on leading meetings in these institutions.

Experience shows that there is often a rapid turnover of individuals in both youth detention centers and short-term facilities. Frequently, attendance at AA meetings in these institutions may not be voluntary. It is prudent to be aware that, like many AA members in the beginning, some people may not believe they have a problem with alcohol and resent attending an AA meeting. It is important to remember that AA is there to offer a message of hope. You may not be able to see immediate results, but a seed may be planted."

So, what does this mean, and why highlight it? Stemming from the single factor of length of stay, or as the Workbook termed it "rapid turnover of individuals." Historically we have experienced a much greater willingness with our Prisons wanting us to have meetings behind their walls, than our Jails or Juvenile facilities. Not that we do not have some where meetings are taken in, but the numbers speak for themselves. 100% of our Area 92 Prisons have meetings, whereas only a fraction of our Jails and Juvenile centers welcomes us in with meetings. Their residents simply are not there long enough. So, we support in different ways, often heavily relying on our message of Hope being carried by our literature.

Our level of involvement and activities in our Prisons though are starkly different. They well could be held up as pinnacle examples of AA's effectiveness at carrying its Message in the corrections arena. Here in Area 92, this has been the case for decades, long before we were even Area 92. In fact, we have the unique and distinct claim to having our Walla Walla Pioneer Group be the second registered AA group meeting ever behind the walls, founded only weeks after San Quinten. And it is also the longest continuous running correctional facility group in the world.

So, what goes on with AA in our Area 92 Prisons? We have five Prisons: Airway Heights next door to Spokane WA, Coyote Ridge in Connell WA, ICIO in Orofino ID, NICI in Cottonwood ID, and WSP in Walla Walla WA. All five of our Prisons have impressive levels of involvement, so we shall fairly take them one at a time, in alphabetical order. This edition we will spotlight and look at what goes on in our North Idaho Corrections Institution (NICI) in Cottonwood ID.

Cottonwood Idaho is located roughly 100 miles directly east of Walla Walla WA, but travel distance via automobile will take nearly three hours and over 150 miles. Both these facilities are our Area 92's most southernly located Prisons.

NICI or "Cottonwood" as you will commonly hear it referred, resides in our District 7. This District has the distinct claim as our only District with two Prisons within its territory. And fortunate for Cottonwood and the other facilities in District 7, this District has for years and years been strong supporters with a high level of responsible outreach with their Hand of AA in supporting their correctional facilities. Not only does our District 7 have successive history of a District Corrections Chair, but they have a District level Corrections Committee established to consistently serve their facilities.

The NICI website opens with this description of our Cottonwood facility:

"NICI is a former military radar station north of the small town of Cottonwood. This facility is a programspecific prison with an operating capacity of 428 male residents. NICI primarily houses residents sentenced under a retained jurisdiction sentence. Retained jurisdiction provides a sentencing alternative for courts to target individuals who might, after a period of programming and evaluation, be viable candidates for probation rather than incarceration."

Is there a certain characteristic of this facilities description that jumps out at you? Like maybe this line here, "program-specific prison". Is this not essentially what we are as AA's performing Service work in Corrections? Offering a message of Hope with a *specific program* of Recovery in a Solution that works? These types of facilities typically are very receptive to working with us.

GSO's records list Cottonwoods first registered meeting as the "North Idaho Correction Group" activated in 1979, but no listed inactivation date. Next was the "Cotton Club Group" active from 1989-2010. Currently Cottonwood has the "We Do Recover" group, which was formed and registered, post COVID, July of 2024. This group meets weekly with attendance reaching as many as 30 plus and has a monthly speaker meeting which always welcomes volunteer speakers to step up for.

Literature support to Cottonwood primarily comes from individuals and Groups within District 7 through their Pink Can efforts. Area 92 supports with a couple Grapevine subscriptions and any peak events which may activate a request to Area for Big Books, 12 x 12's, or Daily Reflections and such. Area also supports by disseminating any fliers and needs for Volunteers to help carry the message into their meetings.

One important thing to remember when it comes to meetings in facilities, there is an extremely important relationship that must be established and maintained between the correctional professional who oversees community involvement (Community Partnership Program Coordinator or CPPC) and the primary AA Member, usually the Volunteer Coordinator. Often this relationship will last for years when nurtured.

However, if the facilities CPPC person feels AA is not need or wanted, then we do not get in, nor sometimes even get literature in. As District Corrections Chairs, these are the persons they serve. AA Volunteers and their Coordinator do not have "rotations" or "terms", they have *passion*, and most have been doing this AA work for many years. As Area and Districts, we do not govern, manage, or have any authority over these activities, we support them in their efforts. If you would be interested in being one of these persons with *passion* and help support the Cottonwood facility, please reach out and contact District 7's Corrections Chair to get the process started, or myself at the Area 92 level. It is Service you won't regret!

For those of you approaching the end of your rotation, we hope your service has been a joyous and fulfilling experience. We have immense gratitude for your efforts to carry the A.A. message through service on a Literature Committee.

If you have rotated on, please forward this report to your new Literature Chairperson.

For those of you who are new, we communicate with you periodically during the year to provide current literature information from the A.A. World Services Board, the General Service Office Publishing Department and the trustees' and Conference Committees on Literature. The next Activity Update will be written after the 2025 International Convention, which is being held from July 3-6 in Vancouver, British Columbia. We hope to have the next update available to you by mid-August 2025.

What's New?

The <u>Literature Committee Workbook</u> was released mid-September 2024 and has been very well received. The initial printing sold out in 2 months with solid engagement through the aa.org website as well. The workbook is back in stock and available for Literature Committee chairs and interested members.

The <u>2046-2026 A.A. Service Manual/Twelve Concepts for World Services</u> went on sale in early December. Between December 6, 2024, and January 2, 2025, more than 6,200 copies were sold. The *A.A. Service Manual* is another resource which some members find particularly useful in electronic format.

The *Plain Language Big Book: A Tool for Reading Alcoholics Anonymous* went on sale on November 1, 2024. 71,749 copies were sold between November 1 and November 18. A second printing was placed on November 24, 2024; more information can be found within this letter from the General Service Board Chair: PLBB Second Printing.

The Plain Language Big Book: A Tool for Reading Alcoholics Anonymous is also available as an e-book and is accessible on Corrections tablets throughout the United States.

One of the primary functions of the General Service Office is to serve as a repository of A.A.'s shared experience in Canada and the United States. Sharing local experiences with us is a valuable contribution towards the fulfillment of G.S.O.s ongoing purpose.

We continue to receive feedback from local committees and members on how they are using new materials, including the *Plain Language Big Book*, to carry A.A.'s message. If you have experiences which you would like to share, about the use of literature in carrying A.A.'s message, we would love to hear from you.

The visionary words from the "Foreword to the First Edition (*Alcoholics Anonymous*)" are alive and well:

"We shall be interested to hear from those who are getting results from this book, particularly from those who have commenced work with other alcoholics."

Current Projects

- Fifth Edition Big Book (Alcoholics Anonymous):
 The drafting of expanding content in Appendix III: "The Medical View on A.A." and Appendix V: "The Religious View on A.A." has begun. The subcommittee is finalizing its selections of personal stories for review by the trustees' Literature Committee and the Conference Committee on Literature.
- Development of a Fourth Edition Big Book Alcohólicos Anónimos (Spanish): The creation of the draft Fourth Edition Alcohólicos Anónimos is being guided by an Appointed Committee Member (ACM) of the trustees' Literature Committee and a working group of Hispanic A.A. members. The working group recently added a new member from Quebec and is looking to add an additional member from Puerto Rico. The working group is proceeding to the next stage in selecting personal stories and continues to receive newly re-translated chapters.
- Update of the pamphlet "A.A. for the Native North American": The working group, comprised entirely of indigenous A.A. members, has completed a selection of 15 personal stories, provided a new introduction, and selected new cover art developed by an indigenous artist.

It may be worth noting that A.A. still relies on literature sales to help fund Twelfth Step service around the world, and purchasing locally supports A.A.'s international and local service entities. A.A.'s Conference-approved literature is intentionally priced to balance the need for literature sales with the desire to keep literature inexpensive so that anyone who needs a book can purchase the materials they need.

Most, if not all, A.A. literature can be found on the aa.org website. In some cases, these listings will provide a brief description of the literature and a link to purchase through the online bookstore. Many pieces of literature can be viewed and read online. These can be found through the search function, or by navigating through "Resources" to "Literature." Results can be filtered by Subject, service committee, or format.

Thank you for your service to the current and future members of Alcoholics Anonymous in extending A.A.'s hand through our Conference-approved literature.


